Resolution No. 073-2020, Series of 2020

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PAPER SHREDDER (HEAVY DUTY)

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, pursuant to its mandate to ensure data protection through the proper disposal of documents to avoid unauthorized disclosure and access, NPC saw it fit to procure three (3) heavy duty paper shredder under approved amended ISSP FY 2018-2020 and 2019 APP Item No. 03-2019-224 with an Approved Budget for the Contract (ABC) amounting to Php75,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to three (3) suppliers: 16/35mm Production Supply, Avid Sales Corporation and Vitara Marketing, with only the latter submitting its quotation together with two (2) others: Business Machines Corporation (BISMAC) and BayanPC Technologies Inc.;

WHEREAS, the BAC members proceeded to evaluate the submitted quotations and determined that two of the bidders failed to submit complete eligibility requirements provided under R.A. 9184, leaving Vitara Marketing with the single calculated and responsive quotation at a bid price of Php 72,000.00, passing the technical, legal and financial requirements mandated under R.A. 9184;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the engagement of contract for the procurement of paper shredder (heavy duty) to VITARA MARKETING,

having the single calculated and responsive quotation in the total amount of **Seventy-Two Thousand Pesos** (Php72,000.00);
