Resolution No. 069-2020, Series of 2020

RECOMMENDING THE AWARD FOR THE SUPPLY AND INSTALLATION OF TIRE FOR THE NPC SERVICE VEHICLE

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to be able to effectively perform its mandate, NPC, on various dates, procured several vehicles as herein reflected in the Terms of Reference herein attached as Annex "A";

WHEREAS, the tires of these vehicles have never been replaced since it was purchased and has been made a subject of the inspection by the car dealership, Inspection Reports are herein attached as Annex "B";

WHEREAS, there is a need to ensure the safety of the NPC personnel using these vehicles and ensure that the procured assets of the Commission are road-worthy and well-maintained;

WHEREAS, Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as "Government Procurement Reform Act" allows for an alternative method of procurement through Small Value Procurement when the amount involved does not exceed the thresholds prescribed in Annex "H" of R.A. 9184's IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to eight (8) suppliers, however, no quotations were received, thus the posting was extended, after which, two (2) suppliers submitted their quotations;

WHEREAS, the BAC members proceeded to evaluate the submitted quotations and determined that one bidder failed to submit their compliance to the technical specifications, leaving Toyota Bicutan Parañaque with the single calculated and responsive quotation at a bid price of Php 49,276.54 and passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the supply and

installation of tire for the NPC service vehicle to Toyota Bicutan Parañaque in the total amount of Forty-nine Thousand Two Hundred Seventy-six and 54/100 Pesos (Php 49,276.54).
