RECOMMENDING THE APPROVAL OF THE AWARD FOR THE ENGAGEMENT OF CONTRACT FOR THE PROCUREMENT OF CCTV SYSTEMS OF THE NATIONAL PRIVACY COMMISSION

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to be able to effectively perform its mandate, NPC should have a secure office within which to conduct its day-to-day operations;

WHEREAS, in order to ensure the security of its offices, the management of NPC saw it fit to procure CCTV Systems under APP Item No. 03-2019-221 with an Approved Budget for the Contract (ABC) amounting to Php150,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, based on the quotation and technical specifications submitted, the NPC Bids and Awards Committee (BAC) determined that Imax Technologies Inc. submitted the single calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of the contract for the procurement of CCTV Systems to *IMAX TECHNLOGIES INC*. with the single calculated and responsive quotation in the total amount of Php122,739.00.
