Resolution No. 080-2020, Series of 2020

RECOMMENDING THE AWARD FOR THE PROCUREMENT OF CY 2021 PLANNER WITH NPC LOGO

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order for the NPC personnel to better monitor their targets NPC saw it fit to procure CY 2021 Planner with NPC Logo under APP Item No. 2020-0125 with an Approved Budget for the Contract (ABC) amounting to Php56,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to four (4) suppliers: Erzalan Printing Press, Gorilla Trading, Kayumanggi Press Incorporated and Yekel Trading, however no quotation was received, thus the posting was extended and was sent to the same suppliers, among which only the latter submitted its quotation. Aside from Yekel Trading, RPK3 Consumer Goods Wholesaling also submitted its quotation;

WHEREAS, the BAC members proceeded to evaluate the submitted quotations and determined that RPK3 Consumer Goods Wholesaling failed to submit a compliant Omnibus Sworn Statement and also failed to fully comply with the required technical specifications;

WHEREAS, Yekel Trading having passed the technical, legal, and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act, was declared to have the single calculated and responsive quotation at a bid price of Php54,000.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the Procurement of CY 2021 Planner with NPC Logo to Yekel Trading with the single calculated and responsive quotation in the total amount of Fifty-four Thousand and 0/100 Pesos (Php54,000.00).
