Resolution No. 084-2020, Series of 2020

RECOMMENDING THE AWARD FOR THE ENGAGEMENT OF SERVICE FOR THE PRINTING OF NPC ANNUAL REPORT FOR CY 2019 IN COLLABORATION WITH FPMD

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, pursuant to its mandate to inform the public about its purpose, functions and activities, NPC saw it fit to procure service for the Printing of NPC Annual Report for CY 2019 in Collaboration with FPMD under APP Item No. 2020-0001 with an Approved Budget for the Contract (ABC) amounting to Php100,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to four (4) suppliers among which only two (2) submitted their quotations namely: Gorilla Trading and Innovation Printshoppe, Inc. These two were joined by two others, AG3 Colors Printing Press and LJB Printing Services. Among these four (4) suppliers who submitted their quotations, LJB Printing Services failed to submit its Omnibus Sworn Statement leaving three (3) bidders eligible.

WHEREAS, the BAC members proceeded to evaluate the three (3) submitted quotations and determined that the lowest calculated and responsive quotation belongs to AG3 Colors Printing Press at a bid price of Php98,250.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the engagement of printing service for the NPC Annual Report for CY 2019 in Collaboration with FPMD to AG3 Colors Printing Press with the lowest calculated and responsive quotation in the total amount of Ninety-Eight Thousand Two Hundred Fifty Pesos and 0/100 Pesos (Php98,250.00).
