Resolution No. 018, Series of 2020

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF ADOBE CREATIVE SOFTWARE SUBSCRIPTION

WHEREAS, the National Privacy Commission (NPC), mandated to monitor and ensure the country's compliance with international standards set for data protection, aims to fulfill its mission and vision to be a world class regulatory and enforcement agency that is committed to excellence. In view thereof, the NPC sees it as essential to procure the subscription to several creative productivity software to provide general support services to its select offices and divisions in performance of its mandates and functions;

WHEREAS, the use of creative productivity software is vital in delivering public services and ensuring quality output of NPC divisions in their day-to-day tasks which include but not limited to: (1) PIAD, for design and production of internal and other information and educational campaign materials; (2) PPO and OPC, for redaction of advisory opinions, adjudication documents, and other documents to be redacted; and (3) CMD, for generation of certificates of registration;

WHEREAS, the Adobe Creative Software Subscription, being an ICT resource, is one of the approved items under the NPC Information Systems Strategic Plan (ISSP) covering the Fiscal Year 2020 under the Government-Wide Medium-Term Information and Communications Technology Harmonization Initiative (MITHI);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 also known as the "Government Procurement Reform Act", recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (PHP1,000,000.00) and not covered by the alternative mode of Shopping under Section 52 of RA No. 9184 and its IRR;

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted on 06 May 2020 the Request for Quotations (RFQs) in the Philippine Government Electronic Procurement System (PHILGEPS), the NPC website and bulletin board, and sent RFQs through electronic mail to various suppliers. Among the suppliers who responded were Mybusybee, Inc., Tiger Consulting and Software Devt., Inc, and Ynzal Marketing Corporation;

WHEREAS, upon the deadline for submission of quotation on 11 May 2020, the NPC-BAC Secretariat opened the quotations received and proceeded to evaluate the compliance of the offers against the necessary legal, technical, and financial requirements;
