

BIDS AND AWARDS COMMITTEE BAC Resolution No.125-2020, Series of 2020

RECOMMENDING THE AWARD OF CONTRACT FOR THE FOR THE PROCUREMENT OF LARGE FORMAT COPIER, HIGH-SPEED INKJET PRINTER TO COPYLANDIA OFFICE SYSTEMS CORPORATION, THE DECLARED SINGLE CALCULATED AND RESPONSIVE BIDDER

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to efficiently produce and reproduce office documents, the NPC saw it fit to procure a large format copier, high speed inkjet printer under APP Item No. 03-2019-227 with an Approved Budget for the Contract (ABC) amounting to Php3,600,000.00;

WHEREAS, this item of procurement shall be under the mode of Competitive Bidding pursuant to Section 10 Rule IV of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A. 9184);

WHEREAS, on 18 November 2020, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) conducted a pre-procurement conference where the details pertaining to this procurement was discussed and clarified;

WHEREAS, on 23 November 2020, the Invitation to Bid was posted in the PhilGEPS and NPC website as well as the NPC bulletin board together with the Bidding Documents. Invitations to observers were also sent in accordance with Section 13 of the RIRR of R.A. 9184;

WHEREAS, on 1 December 2020, the Pre-bid Conference was conducted where a prospective bidders clarified some concerns. Such concerns were then addressed through the Supplemental Bid Bulletin issued by the NPC, a copy of which were furnished to the prospective bidders and published in the NPC website, bulletin board. However, the same was not posted in the PhilGEPS website due to the migration from PhilGEPS Alternative Posting Tool to the new portal (https://notices.philgeps.gov.ph). As per Advisory, the PhilGEPS Alternative Posting Tool (https://notices.ps-philgeps.gov.ph/main/) where the Invitation to Bid for this procurement item is posted, will only be accessible for search and view of the procurement opportunities and

for the posting of awards posted from 1 November 2020 until 27 November 2020, the copy of the Advisory is attached herein as Annex "A";

WHEREAS, the NPC-BAC set the deadline of submission of the Bids on 14 December 2020 at 10:00 A.M. where only one (1) bidder, Copylandia Office Systems Corporation, submitted its bid;

WHEREAS, on the same date, at 01:00 P.M., the NPC-BAC proceeded to open the bid submitted and conduct preliminary evaluation to determine the bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements. The NPC-BAC with the assistance of the BAC-Technical Working Group (BAC-TWG) checked the submitted documents of the bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion in accordance with Section 25 of the IRR of R.A. 9184;

WHEREAS, upon inspection and evaluation of the eligibility requirements submitted, it was determined that Copylandia Office Systems Corporation passed all the eligibility requirements prescribed in accordance to the provisions of the RIRR of R.A. 9184;

WHEREAS, immediately after determining compliance with the requirements in the first envelope, the BAC opened the second bid envelope containing the financial proposal of the eligible and technically complying bidder and determined that it passed all the financial requirements and was recommended for bid evaluation;

WHEREAS, on 16 December 2020, the BAC conducted a bid evaluation in accordance with Section 30 of the RIRR of RA 9184 and prepared the corresponding Abstract of Bids as Calculated attached as Annex "B" where it also declared that Copylandia Office Systems Corporation passed the bid evaluation with the Single Calculated Bid amounting to Php 3,550,000.00 and was recommended for the post-qualification evaluation by the BAC-TWG;

WHEREAS, on 28 December 2020, the NPC-BAC proceeded to review the Post-Qualification Report submitted by the BAC-TWG, attached as Annex "C", and adopted the same;

WHEREAS, noting no issues in the BAC-TWG Post-Qualification Report, it was moved and seconded to declare Copylandia Office Systems Corporation as the single calculated and responsive bidder;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, that the sole bidder, Copylandia Office Systems Corporation, be declared as the single calculated and responsive bidder and recommend that it be awarded the contract for the procurement of large format copier, high-speed inkjet printer amounting to THREE MILLION, FIVE HUNDRED FIFTY THOUSAND PESOS (Php3,550,000.00);
