Resolution No. 123-2020, Series of 2020

RECOMMENDING THE AWARD FOR THE PROCUREMENT OF OFFICE 365 (E1)

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to effectively pursue NPC's mandate in its day-to-day operations, the NPC saw it fit to procure Office 365 under APP Item No. 2020-0179 with an Approved Budget for the Contract (ABC) amounting to Php326,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A. 9184) recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR and provided, that in case of Goods, the procurement does not fall under shopping in Section 52 of the RIRR;

WHEREAS, Section 18 of the 2016 IRR provides that specifications for the procurement of Goods shall be based on relevant characteristics, functionality and/or performance requirements and reference to brand names shall not be allowed except for items or parts that are compatible with the existing fleet or equipment of the same make and brand, and to maintain the performance, functionality and useful life of the equipment. This procurement referencing to brand name is necessary since the NPC is already using Office 365 email service since 2017 thus it is recommended to procure licenses under the same subscription for software compatibility and security;

WHEREAS, upon seeing the NPC postings, two (2) bidders, namely, First Datacorp and Terabit Computer Systems Corporation submitted their quotations;

WHEREAS, the evaluation report made by the BAC-Technical Working Group (TWG) states that both the quotations complied with the technical specifications as required under the revised IRR of R.A. 9184;

WHEREAS, the BAC members proceeded to evaluate the bids and determined that only First Datacorp complied with all eligibility requirements, whereas, Terabit Computer Systems Corporation failed to attached its Secretary's Certificate in its Omnibus Sworn Statement, making First Datacorp the single calculated and responsive quotation at a bid price of Php324,759.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for procurement of Office 365 to First Datacorp, with the single calculated and responsive quotation in the total
