RECOMMENDING THE AWARD FOR THE PROCUREMENT OF DPO ACE LEVEL 2 AVP

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, one of NPC's mandate is to raise public awareness regarding data privacy. Thus, the NPC saw it fit to procure DPO ACE Level 2 AVP under APP Item No. 2020-0167 with an Approved Budget for the Contract (ABC) amounting to Php800,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to three (3) suppliers, namely, Telenetwork Media Center Inc., Microdata Systems and Management, Inc., and Audiowitch with all of them failing to submit their quotation;

WHEREAS, upon seeing the posted RFQ, Ten O Five Productions Inc. and Adrow Creatives, Inc. submitted their quotations;

WHEREAS, the BAC members proceeded to evaluate the quotations submitted and determined that Ten O Five Productions Inc. is the bidder with the lowest calculated and responsive quotation at a bid price of Php 650,000.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of DPO ACE Level 2 AVP to Ten O Five Productions Inc. with the lowest calculated and

responsive quotation in the total amount of Six Hundred Fifty Thousand and 0/100 Pesos (Php650,000.00).
