BAC Resolution No. 033-2021, Series of 2021

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF ACRYLIC SHIELD

WHEREAS, the National Privacy Commission (NPC), approved its FY 2021 Annual Procurement Plan (APP) which includes the procurement of acrylic shields under APP Item Number 2021-0102 and chargeable against Other Supplies and Materials Expenses (GAS-MOOE);

WHEREAS, the procurement of acrylic shields is to ensure the compliance of the NPC to the strict health protocols during the pandemic, and to support Privacy Commission Order No. 007, s. 2020 or the "Guidelines Adopting Alternative Work Arrangement and Mechanisms on the Resumption of Services during the "New Normal" Situation Amid the COVID-19 Pandemic." The acrylic shields will be used mainly during the conduct of physical case hearings in line with the proposal of the NPC's Complaints and Investigation Division;

WHEREAS, Section 53.9 of the revised Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website, NPC website, and the NPC bulletin board on 16 March 2021, and was likewise sent to four suppliers, namely, Ban Bee Commercial Co., Inc., Yekel Trading, Twenty 8 Office Supplies Trading and Ceboom Enterprises, with only the latter submitting its bid.

WHEREAS, four (4) other bidders submitted their quotations within the set deadline, namely, Gober Technologies Corporation, Awards Central Philippines, Inc., DVK Philippines Enterprises and N.S. Yamsuan Medical and Diagnostic Supplies;

WHEREAS, of the five bidders but three of them failed to pass the required eligibility, thereby leaving only Ceboom Enterprises and DVK Philippines Enterprises;

WHEREAS, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations by Ceboom Enterprises and DVK Philippines Enterprises and determined that both bidders passed all the technical, legal, and financial requirements mandated under R.A. No. 9184;

WHEREAS, Ceboom Enterprises has a bid price of Php115,000.00, while DVK Philippines Enterprises has a bid price of Php118,888.00, effectively making Ceboom Enterprises as the bidder with the lowest calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of Acrylic Shield to **Ceboom Enterprises** for having the lowest calculated and responsive quotation in the total amount of **One Hundred Fifteen Thousand and 0/100 Pesos (Php115,000.00).**
