# RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PAW T-SHIRT

WHEREAS, the National Privacy Commission (NPC), approved its FY 2021 Annual Procurement Plan (APP) which includes the procurement of PAW T-shirt under APP Item Number 2021-0119 and chargeable against Other Supplies and Materials Expenses (OPERATIONS-MOOE) with an Approved Budget for the Contract (ABC) of Php100,000.00;

WHEREAS, the procurement of t-shirts is intended to support the Privacy Awareness Week's (PAW) cause and help uplift the spirit and energy of participants in celebrating PAW;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website, NPC website, and the NPC bulletin board on 27 April 2021, and was likewise sent to three (3) suppliers via electronic mail, namely: Veraliz Marketing, Ceboom Enterprises, and Rulujak Enterprises, but the latter failed to submit;

WHEREAS, on 05 May 2021, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations by Ceboom Enterprises and Veraliz Marketing and determined that only Ceboom Enterprises passed all the technical, legal, and financial requirements mandated under R.A. No. 9184;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of PAW T-shirt to Ceboom Enterprises for being the single calculated and responsive quotation in the total amount of Ninety-Three Thousand and 0/100 Pesos (Php93,000.00) subject to the submission of their original requirements upon signing of the Notice of Award.
