## RECOMMENDING THE AWARD FOR PUBLICATION OF NPC CIRCULAR ON ADMINISTRATIVE FINES

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, NPC is mandated to administer and implement the provisions of the Data Privacy Act of 2012 (DPA) and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, the NPC Circular on Administrative Fines, to be effective and binding, should be published in either the Official Gazette or a newspaper of general circulation;

WHEREAS, in order to be widely circulated, the publication of NPC's Circular on Administrative Fines, has been recommended to be published in three (3) newspapers of general circulation;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the Annual Procurement Plan (APP) under APP Item No. 2021-0100 with Scientific, Scholarly, Artistic Work, Exclusive Technology and Media Services as the mode of procurement and an Approved Budget for the Contract (ABC) amounting to Php300,000.00 for the three (3) newspapers;

WHEREAS, four (4) suppliers were asked to submit quotations, namely: The Philippine Daily Inquirer, Inc., Concept and Information Group, Inc., Manila Bulletin and The Philippine Star with the latter failing to submit its bid. One (1) supplier, People's Chronicle acquired the Request for Quotation (RFQ) through either the postings in the PhilGEPS, NPC website or bulletin board. However, the submitted quotation was above the ABC;

WHEREAS, the BAC members proceeded to evaluate the submitted bids and determined that Manila Bulletin Publishing Corporation, Concept and Information Group, Inc. and The Philippine Daily Inquirer, Inc. all passed the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act, it being the lowest calculated and responsive quotation, at the bid price of Php100,000.00, Php70,761.60 and Php 97,675.20, respectively, all terms being most favorable to the government;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) for his consideration and approval, the award of contract for the Publication of NPC Circular on Administrative Fines to Manila Bulletin Publishing Corporation with a bid price of Php100,000.00, Concept and Information Group, Inc. with a



bid price of Php70,761.60; and The Philippine Daily Inquirer, Inc. with a bid price of Php 97,675.20.
