RECOMMENDING THE APPROVAL OF THE AMENDMENTS IN THE 2020 CONTINUING ANNUAL PROCUREMENT PLAN OF THE NATIONAL PRIVACY COMMISSION

WHEREAS, pursuant to the General Appropriations Act of Fiscal Year 2020 (2020 GAA), the National Privacy Commission (NPC) approved its FY 2020 Annual Procurement Plan (2020 APP);

WHEREAS, on 29 December 2020, the Congress of the Philippines enacted Republic Act No. 11520 (R.A. 11520) which extends the availability of the 2020 appropriations until 31 December 2021;

WHEREAS, Section 7.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known Government Procurement Reform Act, provides that all procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity;

WHEREAS, Section 7.4 of the same IRR provided that all changes to the consolidated APP, including that of the 2020 Continuing APP, may be undertaken every six (6) months or as often as may be required by the Head of the Procuring Entity (HoPE);

WHEREAS, the NPC seeks to amend its existing approved FY 2020 Continuing APP to accurately reflect the procurements and projects of the Commission;

WHEREAS, the only changes that will be effected are the removal of the Professional Service (PCR Test), and the addition of APP Item No. 2020-0204 (Covid-19 Response Items – Covid-19 Equipment) for the Administrative Services Division and APP Item No. 2020-0205 (Disaster Preparedness Supplies and Equipment) for the Human Resource Development Division;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend the approval of the Revised 2020 Continuing APP (as of 07 October 2021), a copy of which is herein attached as Annex "A";
