RECOMMENDING THE AWARD FOR THE PROCUREMENT OF ANTI-VIRUS

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to provide security for all endpoints to avoid cyberattacks, the management of the NPC saw the need to procure enterprise-level anti-virus and endpoint security under APP Item No. 2020-0077 with an Approved Budget for the Contract (ABC) amounting to Php500,000.00 and confirmed to be an item included in the Informations Systems Strategic Plan (ISSP) 2018-2020;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A. 9184) recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR and provided, that in case of Goods, the procurement does not fall under shopping in Section 52 of the IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to several suppliers, namely: Unlink Technologies, Inc., Wordtext Systems, Inc., Imaginet International Inc., and Nimbustechnologies, Inc., who all failed to submit their quotations.

WHEREAS, upon seeing the NPC postings, Wizardtech Data and Network Solutions submitted their quotations;

WHEREAS, the BAC members proceeded to evaluate the bid of Wizardtech Data and Network Solutions Co., who according to the BAC-TWG report on the technical specifications, complied with the requirements;

WHEREAS, the BAC then further evaluated the eligibility documents presented and determined that it complied, making it the single calculated and responsive quotation at a bid price of Php443,750.00, passing the technical, legal and financial requirements mandated under R.A. 9184;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for procurement of Anti-Virus to Wizardtech Data and Network Solutions Co., with the single calculated and responsive quotation in the total amount of Four Hundred Forty-Three Thousand Seven Hundred Fifty and 0/100 Pesos (Php443,750.00).
