## RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF HEALTH KITS

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, NPC is mandated to administer and implement the provisions of the Data Privacy Act of 2012 (DPA) and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, pursuant to Civil Service Commission Memorandum Circular No. 18, s. 2020, CSC-DOH-DOLE Joint Memorandum Circular No. 1, series of 2020 ("Occupational Safety and Health Standards for the Public Sector"), Privacy Commission Order No. 003, s. 2021, dated March 31, 2021, and NPC-HSC Resolution 001-2021, the NPC shall continuously provide health and wellness programs for all NPC personnel regardless of employment status which includes the provision of health kits quarterly in addition to the Personal Protective Equipment;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the FY 2020 Continuing Appropriations (RA 11520), programmed under the NPC FY 2020 APP - Continuing with Item No. 2020-0201 and with Approved Budget for the Contract (ABC) amounting to Php912,000.00;

WHEREAS, Section 53.9 of the Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website, NPC website, and the NPC bulletin board on 18 June 2021, and was likewise sent to four suppliers via electronic mail. From the four suppliers that were sent a quotation, only Silent Worker Marketing submitted a quotation and was joined by three others, namely: Meraki Digital Printing Services, L. Victoria Trading, and Pharmastar International Trading Corp.;

WHEREAS, Meraki Digital Printing Services failed to comply with all the eligibility requirements as it did not submit the latest revised format of the Omnibus Sworn Statement;

WHEREAS, among the three remaining eligible suppliers, Silent Worker Marketing has the lowest calculated and responsive quotation at a bid price of Php748,600.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of Health Kits to Silent Worker Marketing having the lowest calculated and responsive quotation in the total amount of Seven Hundred Forty-Eight Thousand Six Hundred and 0/100 Pesos (Php748,600.00) subject to the presentation of its original documentary requirements upon signing of the Notice of Award (NOA).
