WHEREAS, the Purchase Request (PR) for the Cloud Hosting for NPC Website was approved by the Head of the Procuring Entity, with the Public Information and Assistance Division (PIAD) as the End-User, as per P.R No. 22019-0033;

WHEREAS, the NPC Revised Annual Procurement Plan for 2019 as of 5 March 2019 (Based on the Re-enacted Budget) includes an allocation for said software per APP Line Item No. 03-2019-018 with an Approved Budget for the Contract (ABC) amounting to Php250,000.00, with Agency-to-Agency as the mode of procurement;

WHEREAS, Section 53.5 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognizes the use of Negotiated Procurement (Agency-to-Agency) for Infrastructure Projects and Consulting Services from another agency from the GoP, such as the Department of Budget and Management-Procurement Service (DBM-PS), which is tasked with centralized procurement of common-use supplies for the GoP in accordance with Letters of Instruction No. 755¹ and E.O. 359, s. 1989²;

WHEREAS, the procurement of Cloud hosting subscription, according to the Price Quotation of DBM-PS, shall amount to TWO HUNDRED FORTY-EIGHT THOUSAND FORTY-SEVEN PESOS ELEVEN CENTAVOS ONLY (Php248,047.11) which is within the ABC;
