# SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE PRINTING OF PERMANENT ID AND CUSTOMIZED ID LACE OF NPC TO IRENTRADE INDUSTRIAL SALES AND SERVICES

WHEREAS, the procurement request for the printing of NPC officials and employees' permanent ID and customized ID lace was approved by the Head of the Procuring Entity upon representation and recommendation of the End-user;

WHEREAS, the 2018 Annual Procurement Plan of NPC includes an allocation for the printing of permanent ID and customized ID lace amounting to Php50,000.00 with the mode of procurement as Small Value Procurement;

WHEREAS, Section 53.9 of CY 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognize the use of Negotiated Procurement (Small Value Procurement) for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (PhP1,000,000.00);

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted on April 27, 2018 the request for quotation (RFQ) in the Philippine Government Electronic Procurement System, NPC Website and bulletin board, and sent RFQs to Silent Worker Marketing, Jadtwice Print Media Dealer and Tanjer Enterprises;

WHEREAS, upon the deadline for submission of quotation on April 30, 2018, the NPC BAC Secretariat opened the quotations received and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that Irentrade Industrial Sales and Services offered the Lowest Calculated and Responsive Quotation in the amount of FORTY THOUSAND PESOS ONLY (Php40,000.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the printing of permanent ID and customized ID lace of NPC to "Irentrade Industrial Sales and Services" in the total amount of Php40,000.00.
