**SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE
CUSTOMIZED T-SHIRT FOR NPC SPORTS FEST TO
SILENT WORKER MARKETING, INC.**

WHEREAS, the National Privacy Commission recognizes the importance of a healthy lifestyle of the government workforce and improving productivity and morale of its officials and employees;

WHEREAS, the purchase request (PR) for the customized t-shirts for NPC sports fest was approved by the Head of the Procuring Entity upon representation and recommendation of Human Resource Development Division (HRDD) as End-User, as per P.R No. 2018-0124;

WHEREAS, the revised 2018 Annual Procurement Plan (APP) of NPC includes an allocation for the aforementioned services amounting to Php25,000.00 and the mode of procurement as Small Value Procurement (SVP);

WHEREAS, Section 53.9 of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognizes the use of SVP for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted Request For Quotations (RFQ) on PhilGEPS and sent RFQs to Silent Worker Marketing, IFSD Trading and IJA Enterprises on 05 September 2018

WHEREAS, upon the deadline for submission of quotation on 10 September 2018, the NPC BAC Secretariat opened the quotations received and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that Silent Worker Marketing offered the Lowest Calculated and Responsive Quotation in the amount of TWENTY-FOUR THOUSAND AND SIX HUNDRED PESOS ONLY (Php 24,600.00);

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the NPC Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for the production of customized T-Shirt for NPC Sports Fest to "SILENT WORKER MARKETING" in the total amount of Php24,600.00.






