BAC Resolution No. 007, Series of 2019

RECOMMENDING THE AWARD OF CONTRACT FOR THE PRINTING OF GAD T-SHIRT TO SILENT WORKER MARKETING

WHEREAS, pursuant to Republic Act No. 6949, the National Privacy Commission (NPC) joins the celebration of the 2019 Women's Month this March with the theme: "We Make Change Work for Women", paying tribute to the strong and resilient "Juanas" who brought inspiring changes in NPC and in the country;

WHEREAS, the Purchase Request (PR) for the printing of GAD T-shirt for the 2019 Women's Month Celebration was approved by the Head of the Procuring Entity, with the NPC-GAD as the End-User, as per P.R. No. 2019-0024;

WHEREAS, the NPC Annual Procurement Plan for 2019 includes an allocation for said activity with an approved budget for the contract amounting to Php11,000.00, with Small Value Procurement as the mode of procurement;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA No. 9184 recognizes the use of Small Value Procurement as an alternative method of procurement where the amount does not exceed One Million Pesos (Php 1,000,000.00) and the good is not covered by Shopping under Section 52 of RA No. 9184 and its IRR;

WHEREAS, the NPC Bids and Awards Committee (BAC), through its Secretariat, sent Request for Quotations (RFQs) on 27 February 2019 to Silent Worker Marketing, Tanjer Enterprise & Jastra Corp.;

WHEREAS, the NPC-BAC Secretariat proceeded to evaluate the compliance of the offer with the legal, technical, and financial requirements as provided under the same IRR, only Silent Worker Marketing was able to comply to the requirements;

WHEREAS, based on the result of the evaluation, a copy of which is attached hereto as Annex "A", the NPC-BAC determined that SILENT WORKER MARKETING tendered the Single Calculated and Responsive Quotation in the amount of Ten Thousand Eight Hundred Fifty Pesos (Php10,850.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the printing of GAD T-shirt to SILENT WORKER MARKETING in the amount of Ten Thousand Eight Hundred Fifty Pesos (Php10,850.00);
