SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE PLACEMENT OF AUDIO VISUAL MATERIAL FOR THE NATIONAL PRIVACY COMMISSION TO PHILIPPINE INTEGRATED ADVERTISING AGENCY

WHEREAS the request for the Placement of Audio Visual Material for the National Privacy Commission was approved by the Head of the Procuring Entity consistent with the CY 2017 approved Annual Procurement Plan and PPMP of the Public Information and Assistance Division and duly endorsed to the BAC for resolution;

WHEREAS, the 2017 Annual Procurement Plan of NPC includes an allocation for the Placement of Audio Visual Material for the National Privacy Commission amounting to Php600,000.00 with the mode of procurement as Small Value Procurement;

WHEREAS, Section 53.9 of CY 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognize the use of Negotiated Procurement (Small Value Procurement) for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (PhP1,000,000.00);

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted on December 20, 2017 the request for quotation (RFQ) in the Philippine Government Electronic Procurement System, NPC Website and bulletin board, and sent RFQs to Philippine Integrated Advertising Agency, Adspin Advertising, Inc. and Guerilla Advertising Design;

WHEREAS, upon the deadline for submission of quotation on December 26, 2017, the NPC BAC Secretariat opened the quotations received and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that Philippine Integrated Advertising Agency offered the Single Calculated and Responsive Quotation in the amount of FIVE HUNDRED NINETY-TWO THOUSAND NINE HUNDRED FIFTY-SIX PESOS ONLY (Php592,956.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recc mmend the award of contract for the Placement of Audio Visual Material for NPC to "Philippine Integrated Advertising Agency" in the total amount of Php592,956.00.


