## RECOMMENDING THE AWARD FOR THE PUBLICATION OF ANNOUNCEMENT OF ACCEPTANCE OF APPLICATION FOR ACCOUNTABILITY AGENT

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, Accountability Agents are APEC-designated entities that certify that the privacy policies and practices of organizations participating in its Cross Border Privacy Rules (CBPR) system meet the APEC Privacy Framework Standards;

WHEREAS, the Philippines needs to appoint Accountability Agent(s) in order to fully participate in the APEC CBPR system and as such, it has been recommended that its invitation for interested applicants be published in three (3) newspapers of general circulation to be widely circulated;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the Annual Procurement Plan (APP) under APP Item No. 2021-0165, with Negotiated Procurement through Scientific, Scholarly, Artistic Work, Exclusive Technology and Media Services as the mode of procurement, and an Approved Budget for the Contract (ABC) amounting to Php320,000.00 for the three (3) newspapers;

WHEREAS, Section 53.6 (e) of the Revised IRR of Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act provides that goods and services can be contracted to a particular supplier if the requirement is for media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media. Further, it is provided that due to the nature of the information to be disseminated, alongside principles of transparency, efficiency and economy, award to more than one (1) supplier may be made by the Procuring Entity.

WHEREAS, based on the market study previously conducted by the end-user to determine the probable sources, herein attached as ANNEX A, the providers who were determined to have the capacity to undertake the project at a more advantageous terms and are technically, legally and financially capable are Philippine Daily Inquirer, Inc., Concept and Information Group, Inc., and Philstar Daily, Inc.;

**WHEREAS**, the BAC proceeded to negotiate with the said suppliers based on the Technical Specifications prepared by the end-user;

WHEREAS, upon evaluation of the submitted quotation and eligibility documents, it was determined that Philippine Daily Inquirer, Inc., Concept and Information Group, Inc. and Philstar Daily, Inc. all passed the technical, legal and financial requirements mandated under R.A. 9184 at the bid price of Php97,675.20, Php70,761.60, and Php140,000.00, respectively, all terms being most favorable to the government;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) for his consideration and approval, the award of contract for the Publication of Announcement of Acceptance of Application for Accountability Agent in the total amount of THREE HUNDRED EIGHT THOUSAND FOUR HUNDRED THIRTY-SIX PESOS AND 80/100 ONLY (Php308,436.80), broken down into the following:
