BAC Resolution No. 119-2021, Series of 2021

RECOMMENDING THE AWARD FOR THE PROCUREMENT
OF COMMON-USE SUPPLIES AND EQUIPMENT

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, in order to be able to effectively perform its day-to-day operations, various common use supplies and equipment must be procured;

WHEREAS, common-use office supplies and equipment are usually procured with the Procurement Service of the Department of Budget and Management (PS-DBM) however, the items intended to be procured by the Commission is not available with the PS-DBM as evidenced by the Certificate of Non-availability of Stocks (CNAS) dated 4 October 2021, attached herein as Annex "A";

WHEREAS, Section 52.1(b) of the IRR of R.A. 9184 recognizes Shopping as a method of procuring for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from known suppliers of known qualifications which shall be employed in cases where ordinary or regular office supplies and equipment are not available in the DBM-PS;

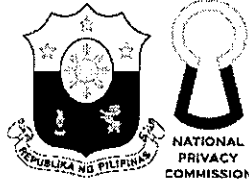
WHEREAS, due to the non-availability of the items in PS-DBM, the Commission has been authorized to procure such items through other sources in accordance with Republic Act No. 9184 and its Implementing Rules and Regulations (IRR) and is now being procured under APP Item No. 2021-0002 and an Approved Budget for the Contract (ABC) amounting to Php733,400.00;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website, NPC website, and the NPC bulletin board on 19 October 2021, and was likewise sent to six (6) suppliers via electronic mail, namely: Best Choice Enterprises, Silent Worker Marketing, Ban Bee Commercial Co., Inc., Twenty 8 Office Supplies Trading, Mostaco Marketing, Zioneyes, and General Merchandise;

WHEREAS, only two quotations were received and they are from Moscato Marketing and Silent Worker Marketing. Since the law requires a minimum of three price quotations to be obtained, the deadline for submission was extended until 02 November 2021, the RFQ was again posted in PhilGEPS website, NPC website, and the NPC bulletin board on 27 October 2021, and again sent to suppliers who failed to submit their quotations;

WHEREAS, one quotation was then received from Banbee Commercials Co., Inc., the BAC members proceeded to evaluate the submitted quotations and determined that the lowest calculated and responsive quotation is that of Silent Worker Marketing in the amount of Six Hundred Ninety Thousand Two Hundred Fifty and 0/100 Pesos (Php690,250.00), passing the technical, legal, and financial requirements mandated under RA 9184 and on terms that are most favorable to the government;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of Common-use Supplies and Equipment to **Silent Worker Marketing** in the total amount of **Six Hundred Ninety Thousand Two Hundred Fifty and 0/100 Pesos (Php690,250.00)**.

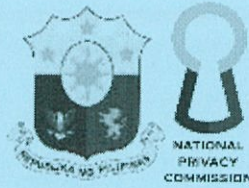




