# RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF ADOBE CREATIVE CLOUD & ACROBAT PROFESSIONAL

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC approved its FY 2021 Continuing Annual Procurement Plan (APP), which includes the procurement of Adobe Creative Cloud & Acrobat Professional under APP Item No. 2021-0189 with the Approved Budget for the Contract of Php 838,000.00;

WHEREAS, said procurement is a necessary creative and document management tool to deliver public services and ensure quality output of divisions through the production of day-to-day tasks, including but not limited to, design and production of audio-visual materials and other campaign/educational materials, generation of certificates of registration, and redaction of personal information from various documents and files;

WHEREAS, a Request for Quotation (RFQ) was posted on the PhilGEPS website and the NPC website, and was likewise sent to three (3) suppliers via electronic mail, namely; Ynzal Marketing Corp., MyBusyBee, Inc., and Keysys Inc.;

**WHEREAS**, five (5) bidders submitted their quotations: MyBusyBee, Inc., GMA New Media Inc., Next Generation Technologies Global Inc., DCI Int'l IT Solutions & Services Corp., and Ynzal Marketing Corporation;

WHEREAS, on 22 September 2022, the NPC Bids and Awards Committee (BAC) proceeded to evaluate the submitted quotations and determined that Next Generation Technologies Global Inc., has the lowest calculated and responsive quotation;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby **RESOLVED**, to recommend the award for the procurement of Adobe Creative Cloud & Acrobat Professional to Next Generation Technologies Global Inc., for being the lowest calculated and responsive quotation in the total amount of Seven Hundred Ninety-Six Thousand Two Hundred Twenty-Seven and 72/100 Pesos (Php796,227.72), subject to the presentation of their original documentary requirements upon signing of the Notice of Award (NOA).
