BAC Resolution No. 134-2022, Series of 2022

### RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENTOF ANNUAL EMPLOYEES' APPRECIATION DAY (DECEMBER)-TOKEN (APP ITEM NO. 2022-0053)

**WHEREAS**, the National Privacy Commission (*NPC* or *Commission*) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, in its pursuit of achieving its vision as the world-class regulatory and enforcement agency upholding the right to privacy and data protection while ensuring the free flow of information and commitment to excellence, its workforce have been working hard with dedication and serve as the backbone of the NPC in providing their time and support in realizing its goal;

WHEREAS, NPC being well cognizant of the value of its employees sought to procure tokens of appreciation for their untiring service and dedication to the Filipino people as well as their support in the achievement of the mission vision of the organization;

WHEREAS, this procurement has a Certification of Availability of Funds (CAF) and has been confirmed to be existing and programmed under the NPC APP with item No. 2022-0053, amounting to THREE HUNDRED FIFTY THOUSAND PESOS (P350,000.00) chargeable against Other Supplies and Materials (GAS-MOOE);

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52

WHEREAS, on 25 November 2022 a Request for Quotation (RFQ) was posted in the PhilGEPS website, the NPC website, and the NPC bulletin board in addition to sending the request to the following suppliers: 1) Best Choice Enterprise; 2) Silent Worker Marketing; 3) Ban Bee Commercial Marketing Co., Inc.; 4) Mostaco Marketing; 5) Ceboom Enterprises; 6) Zioneyes General Merchandise; 7) DVK Philippines Enterprise; 8) King of Kings Trading; 9) Work Habits Trading; 10) Ascan Enterprise; and 11) Balinsasayaw Consumer Good Trading;

WHEREAS, Ascan Enterprise and Balinsasayaw Consumer Good Trading submitted their price quotations;
