BAC Resolution No. 105-2022, Series of 2022

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF
VAWC ADVOCACY TOKENS (APP ITEM No. 2021-0213)

WHEREAS, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, as part of its continuous commitment to end violence against women (VAW), the Commission through the Gender and Development (GAD) Focal Point System - Technical Working Group (FPS-TWG) Committee shall conduct the 2022 18-Day Campaign to End Violence Against Women with the theme, "Putting the Brakes to VAW: Safeguarding Women and Girls in this Digital Age." To support this campaign, the GAD-FPS-TWG proposed to procure advocacy tokens;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing as APP Item No. 2021-0213 in the FY 2021 Continuing Annual Procurement Plan (2021 Continuing APP) and with an Approved Budget for the Contract (ABC) amounting to Php230,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

WHEREAS, a Request for Quotation (RFQ) was posted in PHILGEPS, the NPC website, and the NPC bulletin board and was likewise sent to nine (9) suppliers, namely: Best Choice Enterprise, Silent Worker Marketing, Ban Bee Commercial Co., Inc., Mostaco Marketing, Ceboom Enterprises, Zioneys General Merchandise, DVK Philippines Enterprise, King of Kings Trading, and Work Habits Trading;

WHEREAS, the following three (3) entities submitted their quotations: AV Trading, Ceboom Enterprises, and King of Kings Trading;

WHEREAS, on 25 October 2022, the National Privacy Commission - Bids and Awards Committee (NPC-BAC) proceeded to evaluate all the submitted quotations and determined that the three bids, have passed the technical, legal and financial requirements mandated under RA 9184;

WHEREAS, the bid prices provided by the entities are as follows:

	Php219,500.00
	Php197,500.00
King of Kings Trading	Php214,000.00

WHEREAS, the End-user, GAD-FPS-TWG, in an e-mail dated 24 October 2022, manifested that they have had "unfavorable experiences with [REDACTED] product and service quality in the past. Hence, the GAD-FPS-TWG requests to select the next lowest bidder - King of Kings Trading (Php214,000.00)."¹

WHEREAS, during the evaluation of the submitted quotations for this procurement, the GAD-FPS-TWG, presented to the NPC-Bids and Awards Committee (BAC) their evaluation of [REDACTED] dated 14 June 2022, from a previous procurement with a rating of "did not meet expectations". In the same evaluation form, the GAD-FPS-TWG answered "no" to the question of whether they would recommend the contractor/supplier [REDACTED] in the future;²

WHEREAS, taking into consideration the manifestation of the End-user, King of Kings Trading was determined to have submitted the lowest calculated and responsive bid with a bid price of Php214,000.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the procurement of VAWC Advocacy Tokens to **KING OF KINGS TRADING** for having the lowest calculated and responsive quotation in the total amount of Two Hundred Fourteen Thousand Pesos (Php214,000.00), subject to the presentation of their original documentary requirements upon signing of the Notice of Award (NOA).

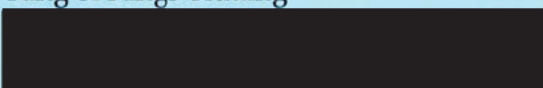


