RECOMMENDING THE APPROVAL OF THE ANNUAL PROCUREMENT PLAN FOR THE FISCAL YEAR 2023 OF THE DIGITAL SECURITY AND PRIVACY QUICK RESPONSE (DSPQR) PROJECT

WHEREAS, Republic Act No. 10844, also known as the Department of Information and Communications Technology Act of 2015, created the Department of Information and Communications Technology (DICT);

WHEREAS, R.A. No. 10844 states that it is the declared policy of the State to provide oversight over agencies governing and regulating the Information and Communications Technology sector and ensure consumer protection and welfare, data privacy and security, foster competition and the growth of ICT sector;

WHEREAS, the same law mandated the DICT to ensure and protect the rights and welfare of consumers and business users to privacy, security and confidentiality in matters relating to ICT, in coordination with agencies concerned, the private sector and relevant international bodies;

WHEREAS, the Republic Act. No. 10173 or the "Data Privacy Act of 2012" mandated the National Privacy Commission to administer and implement the provisions of the Data Privacy Act (DPA), and to monitor and ensure compliance of the country with international standards set for data protection, that is hereby created an independent body to be known as the National Privacy Commission;

WHEREAS, in recognition of the significant synergies and complementarity of working together towards a harmonized approach in performing their respective duties, functions, and mandate, the NPC and DICT have agreed to formalize their intersecting mandates to promote and protect data privacy and consumer rights of the Filipino people, in order to render more effective and efficient public service;

WHEREAS, NPC and DICT have agreed to work together on the deployment of the Digital Security and Privacy Quick Response (DSPQR) Project pursuant to Memorandum of Agreement signed by Secretary Ivan John E. Uy and Privacy Commissioner John Henry D. Naga on 25 October 2023, and notarized on 28 October 2023. The NPC, referred to as the Implementing Agency, shall be the government unit to which the funds are transferred to for the purpose of implementing the said project.

WHEREAS, as the Procuring Entity (PE), the NPC is mandated by law to meticulously and judiciously plan its budget consistent with government fiscal discipline measures;

WHEREAS, Section 7.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Act, provides that all procurement shall be within the approved budget of the PE;
