TERMS OF REFERENCE

PROFESSIONAL SERVICES (HIGHLY TECHNICAL CONSULTANT FOR THE CONDUCT OF SEMINAR WORKSHOP) (APP Item No. 2024 - 0047)

I. BACKGROUND

The National Privacy Commission ("NPC" or the "Commission") is an independent body mandated to administer and implement the Data Privacy Act of 2012 (DPA), and to monitor and ensure compliance of the country with international standards set for data protection.

In compliance with Executive Order (EO) NO. 605, Institutionalizing Structure, Mechanisms and Standards to Implement the Government Quality Management Program Amending for the Purpose Administrative Order No. 161, s. 2006, NPC started its QMS Journey in December 2019. With the assistance of a Highly Technical Consultant whom the NPC engaged for the purpose, the NPC completed the different Modules and was able to produce several outputs required by the ISO 9001:2015 standards/clauses, including the Operations Manuals for declared processes.

The Quality Management System (QMS) refers to the organizational structure, responsibilities, procedures, processes, and resources needed to implement quality management.

The NPC has been certified by the Accredited Certifying Body under the International Organization for Standard (ISO) 9001:2015 last December 2021. The SOCOTEC Certification Philippines, Inc. (ISO Certifying Body) accorded the certification after two (2) audit stages and two (2) Surveillance audits, respectively. The Auditors found that the NPC processes adhere to the requirements of its functions, mandate, and quality management system implementation.

The NPC-Top Management recognizes the necessity to sustain the implementation of the Quality Management System in NPC. Thus, considering the continuous implementation of QMS in NPC, the necessity for the services of the consultant to provide technical assistance to continue to implement the NPC QMS, and develop and/or enhance policies and procedures to support continuous improvement.

II. OBJECTIVES

NPC desires to engage the expertise of the Highly Technical Consultant to continue the necessary training and workshops to equip the NPC officials, employees, Quality Management Representative (QMR), and Quality Management Team (QMT) in sustaining the implementation of QMS ISO 9001:2015 at the NPC. There is a need to prepare for the recertification of the NPC for ISO 9001:2015 by the accredited ISO Certifying Body.

B. Conduct training with lectures, coaching sessions, and workshops through a combination of face-to-face and online platform meetings within the six (6) months contract period, which contract delivery period shall commence after the receipt of the Notice to Proceed (NTP) by the Consultant.

C. Review, revise, and update the NPC Citizen's Charter in accordance with the updated Operations Manuals and existing rules and regulations of the Commission as well as in compliance with the pertinent guidelines issued by ARTA, and other pertinent laws, rules, and regulations.

D. Perform such other tasks related to the implementation of QMS as assigned by the NPC Top Management and/or the Quality Management Representative (QMR).


