**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF
OF PAW ADVOCACY TOKENS (APP Item No. 2024-0034)**

WHEREAS, the National Privacy Commission (*NPC* or *Commission*) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC was tasked to educate the public about data privacy, data protection and fair information rights and responsibilities;

WHEREAS, the NPC will be conducting the 7th Privacy Awareness Week (PAW 2024) which aims to raise awareness among Filipino and the global audience on the country's current data privacy practices and development;

WHEREAS, the Public Assistance and Information Division (PIAD), as the end-user is responsible for information management, including publications and website maintenance and the provisions of public services in the Commission;

WHEREAS, the PAW Advocacy tokens are part of the event's custom merchandise which have served as necessary additions since PAW's very first launch;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Alternative Mode (Small Value Procurement) as a method of procuring services where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR;

WHEREAS, this procurement has a Certification of Availability of Funds (CAF) with APP Item No. 2024-0034 with an Approved Budget for Contract of Php350,000.00;

WHEREAS, a Request for Quotation was posted in the PhilGEPs and NPC website, as well as the NPC bulletin board on 19 March 2024;


WHEREAS, seven (7) bidders submitted their quotations namely: (1) Zioneyes General Merchandise.; (2)E&C General Merchandise ; (3) JDR Training Services; (4) Agave Trading (Corporate Giveaways); (5) Tanjer Enterprises; (6)Work Habits Trading; (7) Elev8 Trading and Marketing Corporation;

WHEREAS, on 26 March 2024, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations and determined that Zioneyes General Merchandise has the lowest calculated and responsive quotation with a bid price amounting to Three Hundred and Eight Thousand Pesos (Php308,000.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the procurement of PAW Advocacy Tokens (APP item No. 2024-0034) to the **ZIONEYES GENERAL MERCHANDISE**, for being the lowest calculated and responsive quotation in the total amount of **THREE HUNDRED EIGHT THOUSAND PESOS (PHP 308,000)** subject to the presentation of their original documentary requirements upon signing of the Notice of Award (NOA).
