#### I. **BACKGROUND**

The National Privacy Commission (NPC) is charged with the administration and implementation of the provisions of the Data Privacy Act of 2012 (DPA), which includes ensuring compliance with the provisions of the DPA and with international standards for data protection and carrying out efforts to formulate and implement plans and policies that strengthen the protection of personal information in the country, in coordination with other government agencies and the private sector.

The Policy Development Division (PDD) is particularly tasked to recommend and develop standards for organizational security measures for protection of personal information, including policies for the processing of sensitive information in government.

With this, the PDD aims to publicize in one (1) newspaper of general circulation various issuances of the Commission.

#### II. **OBJECTIVES**

The NPC aims to publish in one (1) newspaper of general circulation various NPC issuances to be issued by the Commission in 2024 pursuant to Section 18 of Executive Order No. 292:

Section 18. When Laws Take Effect. - Laws shall take effect after fifteen (15) days following the completion of their publication in the Official Gazette or in a newspaper of general circulation, unless it is otherwise provided.

In addition, through this publication, the PDD will be able to contribute to the strategic objectives of Empowered Data Subjects and Ensured world class data privacy standards established in the country.
