I. BACKGROUND

The Legal Division (LD) is the general counsel of the National Privacy Commission (NPC). As such, the LD is regularly consulted about legal matters and requested to review contracts, issue legal opinions, draft pleadings and inter-agency agreements, and develop circulars and policies by the NPC. Given these, the LD requires the acquisition of an online library of laws, jurisprudence, and other issuances, through the renewal of the Philippine Jurisprudence Online Access Subscription, to effectively fulfill its duties to the NPC.

Additionally, an online library is also essential to the rest of the NPC lawyers as this allows them to efficiently perform their duties in their respective divisions. This enables them to stay updated with developments in the legal field and continuously empower people by providing knowledge on data privacy and developing policies on alternative dispute resolution and data privacy. The acquisition of an online library through the renewal of the Philippine Jurisprudence Online Access Subscription is crucial to the efficient legal research and delivery of services of the NPC lawyers to the Commission.

II. OBJECTIVES

The Philippine Jurisprudence Online Access Subscription will provide the following:

- A. Complete and up-to-date database of Philippine laws, jurisprudence, and executive issuances;
- B. Search engine with comprehensive filtering options;
- C. Laws and jurisprudence citators; and
- D. Automatic cross-referencing of cited laws and jurisprudence within and across databases.

III. TECHNICAL REQUIREMENTS/SPECIFICATIONS

- A. The supplier shall be able to provide a Certificate of Sole Distributorship.
- B. The supplier shall be able to provide a comprehensive compilation of Philippine laws and jurisprudence (1901 to present).
- C. Ten (10) to twenty (20) user IDs shall be created for the NPC employees.

- D. The contents must come from official sources only to ensure their accuracy and reliability.
- E. The online database must be capable of being updated on a regular basis (i.e. monthly or annually) and/or whenever necessary.
- F. It must have a search and retrieval software that will facilitate easy access and cross-referencing.
- G. The product must be internet-based and can be accessed from any device (e.g. laptop, tablet, mobile phone).
- H. The supplier shall be able to provide corporate rates for multiple subscriptions.
- I. An after-sales customer support must be available for products and services issues.
