RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF UPS

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC approved its FY 2021 Continuing Annual Procurement Plan (APP) which includes the procurement of UPS under APP Item No. 2021-0042 with the Approved Budget for the Contract of Php 595,000.00;

WHEREAS, said procurement is necessary to protect the network devices of the NPC, particularly in its East Wing, against unexpected power interruption which can lead to damage to hardware, loss of data, and loss of access to the servers that would result in the disruption of NPC's network services;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website and the NPC website, and was likewise sent to four (4) suppliers via electronic mail, namely: VillMan Computers, Intellyx IT Solutions, Next Generation Technologies Global, Inc., and Wireless Link Technologies, Inc.;

WHEREAS, on 22 September 2022, the NPC Bids and Awards Committee (BAC) proceeded to evaluate the submitted quotations by Intellyx IT Solutions, Automation Specialist and Power Exponent Inc. and Next Generation Technologies Global Inc.;

WHEREAS, in their Comment, the NPC BAC Technical Working Group (TWG) opined that the UPS offered by Automation Specialists is not enterprise grade, compared to the ones offered by Next Generation Technologies Global, Inc., and Intellyx IT Solutions which are industry standard when it comes to quality and performance;

WHEREAS, after further evaluation, the NPC BAC determined that Next Generation Technologies Global Inc., has the lowest calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby **RESOLVED**, to recommend the award for the procurement of UPS to Next Generation Technologies Global Inc., for being the lowest calculated and responsive quotation in the total amount of Four Hundred Fifty-Two Thousand Five Hundred Pesos (Php 452,500.00).


