RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF OPTICAL MOUSE

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC approved its FY 2021 Continuing Annual Procurement Plan (APP) which includes the procurement of Optical Mouse under APP Item No. 2021-0194 with the Approved Budget for the Contract of Php 12,000.00;

WHEREAS, said procurement is necessary for the employees of the Commission, particularly the members of the Interim Management Information System Unit (IMISU), to efficiently perform their functions and improve productivity;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website and the NPC website, and was likewise sent to three (3) suppliers via electronic mail, namely: Computechnologies Corporation, Silent Worker Marketing and Ban Bee Commercial Co., Inc. Two other suppliers, Advance Solutions Inc., and Agile Techfrontier Corporation submitted their quotations after seeing the postings;

WHEREAS, on 7 July 2022, the NPC Bids and Awards Committee (BAC) proceeded to evaluate the submitted quotations by Advance Solutions Inc., Agile Techfrontier Corporation and Computechnologies Corporation, and determined that Advance Solutions, Inc. is the supplier with the lowest calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of Optical Mouse to Advance Solutions, Inc. for being the lowest calculated and responsive quotation in the total amount of Four Thousand Eight Hundred (Php 4,800.00), subject to the presentation of their original documentary requirements upon signing of the Notice of Award (NOA).
