RECOMMENDING THE AWARD OF CONTRACT FOR THE PRINTING OF 2021 COMPENDIUM (APP ITEM NO. 2021-0202)

WHEREAS, the National Privacy Commission (*NPC* or *Commission*) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the Commission is tasked to educate the public about data privacy, data protection, and fair information rights and responsibilities, as provided in the Data Privacy Act of 2012 and its implementing rules and regulations;

WHEREAS, the Public Assistance and Information Division (PIAD) is responsible for information management, including publications, and website maintenance, and the provision of public services in the Commission and to fulfill their tasks, PIAD proposes the printing of the 2021 NPC Compendium;

WHEREAS, the 2021 NPC Compendium will help disseminate information materials about the Commission's issuances;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing as APP Item No. 2021-0202 (Printing of 2021 Compendium) in the FY 2021 Continuing Annual Procurement Plan (APP) and with an Approved Budget for the Contract (ABC) amounting Three Hundred Thousand Pesos (Php 300,000.00);

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

WHEREAS, a Request for Quotation (RFQ) was posted in PHILGEPS, the NPC website, and the NPC bulletin board and was likewise sent to four (4) suppliers, namely: GA Printing, Inc., Metro Color Corp., QualiPress Printing Services, and K1 Uniprint;

WHEREAS, four (4) bidders submitted their quotations: Ace Visual Solutions, GA Printing, Inc., Classic Litho Corp, and VJ Graphic Arts, Inc.;

WHEREAS, on 06 October 2022, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations, identified that only
