Resolution No. 077-2022, Series of 2022

#### RECOMMENDING THE AWARD OF CONTRACT FOR THE LEASE OF VENUE

**WHEREAS**, the National Privacy Commission (*NPC* or *Commission*) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the Commission must craft its 2023-2028 Strategic Plans aligned with the 2023-2028 Philippine Development Plan. The Marcos Administration's eight-point Socioeconomic Agenda is aimed at achieving the administration's goals of bringing down the poverty rate to a single-digit and elevating the country's status as an upper-middle income economy. NPC needs to understand its current position, where it is headed and actions to be taken which will require significant investment in the formulation of medium to long term plans;

WHEREAS, the Commission aims to conduct a Strategic Planning session which will define its strategic vision and mission for the years 2023-2028. It will also identify long-term Gender and Development (GAD)-related plans, determining internal strengths, weaknesses and goals, and considering external opportunities and threats;

WHEREAS, accordingly, the Gender and Development Focal Point System-Technical Working Group (GADFPS-TWG), as end-user, proposed the leasing of venue for the three-day NPC Strategic Planning for F.Y. 2023-2028 and Conduct of F.Y. 2023-2028 GAD Planning And Budget Workshop as approved by the Head of the Procuring Entity, as per Purchase Request (*PR*) No. 2022-09-0134, with an approved budget for the contract of Php 800,000.00;

WHEREAS, Section 53.10 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes the use of Lease of Venue as alternative mode of procurement to promote economy and efficiency;

WHEREAS, the NPC Bids and Awards Committee (NPC-BAC), through its Secretariat, sent Requests for Quotation on 8 September 2022 through electronic mail to UP Balay Internasyonal, Seda Vertis North, Eastwood Richmonde Hotel, and Novotel Manila;

WHEREAS, policy considerations in Section IV. (D) (9) of Annex H of the 2016 Revised Implementing Rules and Regulations of RA 9184 provide that it is preferred that government agencies lease publicly-owned real property or venue from other government agencies. However, in the Justification provided by the end-user, no government facility satisfactorily fulfilled the technical, documentary, and financial requirements needed by the Commission. UP Balay Internasyonal, in their email to the end-user, said that they cannot accommodate the request due to lack of available rooms in their facilities. The aforementioned email is hereby attached as Annex "A".

WHEREAS, on 12 September 2022, the National Privacy Commission - Bids and Awards Committee (NPC-BAC) proceeded to evaluate the single submitted quotation from Prestige Hotels & Resorts, Inc. doing business under the name and style of Eastwood Richmonde Hotel, and the venue it was offering was rated in accordance with the technical specifications prepared pursuant to the "Rating Factors and Determination of Reasonableness of Rental Rates" (Appendix B of ANNEX "H" of the 2016 RIRR of RA 9184). WHEREAS, the NPC-BAC determined that the Prestige Hotels & Resorts, Inc. doing business under the name and style of Eastwood Richmonde Hotel, has passed the technical requirements mandated under RA 9184 and was determined to have submitted the single calculated and responsive bid at a bid price of SEVEN HUNDRED TWENTY-FIVE THOUSAND PESOS (Php 725,000.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the Lease of Venue for the NPC Strategic Planning for F.Y. 2023-2028 and Conduct of F.Y. 2023-2028 GAD Planning And Budget Workshop to PRESTIGE HOTELS & RESORTS, INC. doing business under the name and style of EASTWOOD RICHMONDE HOTEL for having the single calculated and responsive quotation in the total amount of SEVEN HUNDRED TWENTY-FIVE THOUSAND PESOS (Php 725,000.00) subject to the presentation of its original documentary requirements upon signing of the Notice of Award (NOA).




