RECOMMENDING THE AWARD OF CONTRACT FOR THE LEASE OF VENUE

WHEREAS, the National Privacy Commission (*NPC* or *Commission*) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, in view of the continuous effort of the NPC in the fulfillment of its vision, mission, and mandate, the Human Resource Development Division (HRDD) aims to upskill and further develop the current supervisory and management skills and practices of NPC officials and first-time supervisors and managers through the conduct of Learning and Development (L&D) intervention program on supervisory training;

WHEREAS, the NPC approved its FY 2021 Continuing Annual Procurement Plan (APP), which includes the procurement of Lease of Venue under APP Item No. 2021-0234 with the Approved Budget for the Contract of Php250,000.00;

WHEREAS, Section 53.10 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes the use of Lease of Venue as an alternative mode of procurement to promote economy and efficiency;

WHEREAS, on 26 October 2022, the NPC Bids and Awards Committee (*NPC-BAC*), through its Secretariat, sent Requests for Quotation through electronic mail to Sequioia Hotel Quezon City, Seda Vertis North, and Ramada by Wyndham Manila Central;

WHEREAS, policy considerations in Section IV. (D) (9) of Annex H of the 2016 Revised Implementing Rules and Regulations of RA 9184 provide that it is preferred that government agencies lease publicly-owned real property or venue from other government agencies. However, in the Justification provided by the end-user, the Philippine International Convention Center (PICC), a publicly-owned venue, offers high service cost without lodging as service inclusion. Lodging as service inclusion is required under the Technical Specifications of the End-User. This being the case, the resort to privately-owned venue is more efficient and economical to the government;

WHEREAS, on 28 October 2022, the National Privacy Commission – Bids and Awards Committee (*NPC-BAC*) proceeded to evaluate the single submitted quotation from Paradigma International Inc. *Doing Business Under the Name and Style of Ramada Manila Central*, and the venue it was offering was rated in accordance with the technical specifications prepared pursuant to the “Rating Factors and Determination of Reasonableness of Rental Rates” (Appendix B of ANNEX “H” of the 2016 RIRR of RA 9184). The aforementioned rating table is hereby attached as Annex “A”, wherein it shows that the

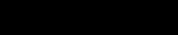

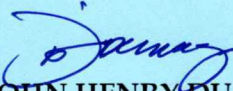


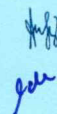
