# RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF HARDWARE AUTHENTICATION DEVICE/ PHYSICAL SECURITY TOKEN (APP ITEM NO. 2021-0241)

WHEREAS, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, to fulfill its mission and vision to be a world class regulatory and enforcement agency that is committed to excellence, the Compliance and Monitoring Division of the NPC (CMD) intends to strengthen the security of its systems and IT resources by following industry best practices in cyber security;

WHEREAS, in conjunction with the above, NPC Circular 16-01 Section 18 states the agency personnel that access to personal data online are required to use multi factor authentication (MFA), although SMS based, and App based MFA are readily available for use, studies show that the use of hardware-based authentication devices is the best option when choosing for MFA:

WHEREAS, the procurement and use of Hardware Authentication Device/ Physical Token will greatly enhance the security and privacy of CMD systems and assets, specifically with regard to the implementation of a hardware based multi-factor authentication device;

WHEREAS, this procurement has a Certification of Availability of Funds (CAF) and has been confirmed to be existing and programmed under the NPC CY 2021 Continuing APP with Item No. 2021-0241, amounting to ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) chargeable against ICT Semi-expendable Expense (OPERATIONS-MOOE);

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

WHEREAS, the NPC Bids and Awards Committee (NPC-BAC) through the BAC Secretariat, then proceeded to post in the PHILGEPS website, the NPC website, and the NPC bulletin board, the Request for Quotation (RFQ) was likewise sent to the following suppliers: 1.) Xitrix Computer Corporation; 2.) Tekzone Computer Sales and Services Inc.; and 3.) Galleon PH.;

WHEREAS, during the period within which documentary requirements were required to be submitted only two suppliers endeavored to submit the same, namely: 1.) Micro Image International Corporation; and 2.) Tekzone Computer Sales and Services Inc., the latter being the only one to have complied with the proper and complete documentation requirements;

WHEREAS, on 24 November 2022, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) evaluated the submission of Tekzone and determined that it passed all the technical, legal, and financial requirements under RA 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of Hardware Authentication Device/ Physical Security Token to TEKZONE COMPUTER SALES AND SERVICES INC. through small value procurement in the total amount of One Hundred Forty Eight Thousand Nine Hundred Pesos (P 148, 900.00) subject to the presentation of its original documentary requirements upon signing of the Notice of Award (NOA).
