BAC Resolution No. 152-2022, Series of 2022

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF SOUND SYSTEM WITH VARIOUS ACCESSORIES (APP ITEM NO. 2021-0242)

WHEREAS, the National Privacy Commission (*NPC* or *Commission*) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the Administrative Services Division (ASD) proposed the procurement of Sound System with Various Accessories as it was recognized as essential to the operation of the Commission. The Sound System with Various Accessories will be used during official meetings, regular activities and programs;

WHEREAS, said procurement is reflected and has been approved in the Commission's CY 2021 Continuing Annual Procurement Plan (APP) under Item Number 2021-0242 with an Approved Budget for the Contract (ABC) amounting to One Hundred Eighty Thousand Pesos (Php 180,000.00);

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

WHEREAS, a Request for Quotation (RFQ) was posted in PHILGEPS, the NPC website, and the NPC bulletin board and was likewise sent to four (4) suppliers, namely: Silent Worker Marketing, Ceboom Enterprise, Avid, and Versatech;

WHEREAS, two (2) entities submitted their quotations: Abenjoy Electronic Service Center and Silent Worker Marketing;

WHEREAS, on 20 December 2022, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate all the submitted quotations and determined that only Silent Worker Marketing, passed the technical, legal, and financial requirements mandated under RA 9184;

WHEREAS, Silent Worker Marketing, was determined to have submitted the single calculated and responsive bid at a bid price of Php 179,800.00;
