RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PSST/KABATAANG DIGITAL - JACKET, CUSTOMIZED

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC is tasked to educate the public about data privacy, data protection, and fair information rights and responsibilities, as provided in the DPA;

WHEREAS, among the continuing programs/projects of NPC that aspire to raise awareness is PRIVACY, SAFETY, SECURITY, and TRUST! (PSST) Online;

WHEREAS, the procurement of the PSST/Kabataang Digital-Jacket, customized is a marketing strategy that will help generate awareness and hype, which will ultimately raise public awareness on data privacy by creating instant and inexpensive brand recognition;

WHEREAS, the NPC approved its FY 2022 Annual Procurement Plan (APP), which includes the procurement of PSST/Kabataang Digital-Jacket, customized with APP No. 2022-0058 with an Approved Budget for the Contract of Php 325,000.00;

WHEREAS, a Request for Quotation (RFQ) was posted at the PhilGEPS website with Reference Number 8878188, and at the NPC website. It was likewise sent to seven (7) suppliers, namely; Silent Worker Marketing, Ceboom Enterprises, Mostaco Marketing, DVK Philippine Enterprises, Zioneyes Gen. Mdse, Work Habits Trading, and Veraliz Marketing;

WHEREAS, three (3) suppliers, namely; Ceboom Enterprises, Stitchactive Enterprises, and Zhujhar Manufacturing Incorporation sent their quotations as requested;

WHEREAS, upon due evaluation, Stitchactive Enterprises, having passed the technical, legal, and financial requirements mandated under RA 9184, has been determined to be the lowest calculated and responsive bidder with a bid price of Php 220,000.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of PSST/KABATAANG DIGITAL-JACKET, CUSTOMIZED to STITCHACTIVE ENTERPRISES in the total amount of Two Hundred Twenty Thousand Pesos (Php 220,000.00), subject to the presentation of their original documentary requirements upon signing of the Notice of Award (NOA).
