RECOMMENDING THE AWARD OF CONTRACT FOR TELEPHONE - LANDLINE

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, telephone-landline service is essential, indispensable, and necessary for the daily operations of the offices, so as not to disrupt the provision of public services;

WHEREAS, the Government Procurement Policy Board (GPPB) has issued Resolution No. 019-2006 adopting the guidelines on the procurement of water, electricity, telecommunications and internet service providers;

WHEREAS, GPPB Resolution Nos. 019-2006 and 41-2017 recognizes that changing telecommunications provider yearly may prove to be more costly to the government;

WHEREAS, Appendix 21 of the 2016 Revised Implementing Rules and Regulations (RIRR) of RA 9184 also acknowledges that telephone lines are critical in the day-to-day pursuit of public business and their continuity ensures proper coordination within the organization and efficient delivery of public service;

WHEREAS, for these reasons, renewal of telecommunication services is allowed provided that the procuring entity must first assess the quality of services provided by its current supplier, and compare the cost charged and the range of services it offers as against other service providers in the area;

WHEREAS, upon assessment, NPC's current service provider, PLDT Inc. continues to display highly acceptable quality of service and did not commit any violation of the contract as evidenced by the Assessment/Justification for the Continued Subscription to PABX and Landline Telephone Services provided by PLDT Inc., herein attached as Annex "A."

WHEREAS, upon assessment, it was also found that it is more advantageous for the NPC to renew its contract with the current provider than engage the service of a new one;

WHEREAS, pursuant to the provisions of GPPB Resolution No. 019-2006 and 41-2017, NPC saw it fit to renew the contract of its current service provider, PLDT, Inc., with the contract commencing from 01 March 2023 until 31 December 2023;

WHEREAS, a Certification of Availability of Funds was issued for this purpose, for APP Item No. 2023-0012 with an Approved Budget of Contract for Php 620,000.00 for a ten-month contract commencing from 01 March to 31 December 2023;

WHEREAS, on 2 February 2023, a Request for Quotation was sent to PLDT Inc.;

WHEREAS, pursuant to this, PLDT Inc., submitted all documentary requirements necessary for the renewal of its services;

WHEREAS, upon due assessment, the NPC Bids and Awards Committee (BAC) determined that PLDT Inc. has complied with the technical, legal, and financial requirements mandated under R.A. 9184;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for **TELEPHONE - LANDLINE (APP No. 2023-0012)**, through renewal, in accordance with GPPB Resolution Nos. 019-2006 and 41-2017 with PLDT, Inc. for a total contract price of Two Hundred Forty-Four Thousand One Hundred Sixty Pesos (Php 244, 160.00) for a period of ten months from 01 March to 31 December 2023.

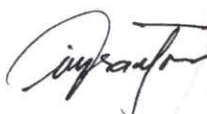

LANDLINE SERVICES RENEWAL AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This LANDLINE SERVICES RENEWAL AGREEMENT (hereinafter referred to as the "Agreement") is made and entered into this FEB 28 2023, in Metro Manila, Philippines, by and between:

The NATIONAL PRIVACY COMMISSION, a government agency mandated to administer and implement the Data Privacy Act of 2012, and to ensure compliance of the country with international standards set for data protection, with office address at the 5th Floor Delegation Building, PICC Complex, Vicente Sotto Avenue, Pasay City, Metro Manila, Philippines, represented herein by its Privacy Commissioner, ATTY. JOHN HENRY D. NAGA (hereinafter referred to as the "NPC");

- and -

PLDT INC., a corporation duly organized and existing under Philippine Laws, with principal office at Ramon Cojuangco Bldg., Makati Avenue, Makati City, herein represented by its duly authorized and designated representative, [REDACTED] (hereinafter to as the "SERVICE PROVIDER").

The NPC and SERVICE PROVIDER shall hereinafter be referred to collectively as the "PARTIES."

WITNESSETH, that:

WHEREAS, on 28 December 2018, NPC and the SERVICE PROVIDER entered into a 12-month contract ("Original Contract") for Trunkline and Managed Private Automatic Branch Exchange (PABX) subscription (the "Existing Services"). A copy of the Original Contract is attached and made an integral part of this Agreement as ANNEX "A";

WHEREAS, NPC has last renewed the Original Contract on 01 April 2022 and remained effective until 31 December 2022 ("Renewal Contract") which, in turn, was extended until 28 February 2023 ("Extension Contract"). Copies of the Renewal Contract and Extension Contract are attached and made an integral part of this Agreement as ANNEXES "B" and "C", respectively;

WHEREAS, the Government Procurement Policy Board (GPPB) has issued Resolution No. 019-2006, as amended by GPPB Resolution No. 41-2017, adopting the guidelines on the procurement of water, electricity, telecommunications and internet service providers;

WHEREAS, GPPB Resolution Nos. 019-2006 and 41-2017 recognizes that changing telecommunications provider yearly may prove to be more costly to the government;

WHEREAS, Section 3.3.1.2 of GPPB Resolution No. 41-2017 allows renewal of telecommunication services, provided that at the end of each year the procuring entity must first assess the quality of services provided by its current supplier, compare the cost charged and the range of services it offers as against other service providers in the area;

WHEREAS, pursuant to the provisions of GPPB Resolution No. 019-2006 and 41-2017, the management of NPC saw it fit to renew the contract of its current service provider;

WHEREAS, the current service provider, PLDT INC., has submitted all the documentary requirements for renewal;

WHEREAS, on 26 January 2023, the NPC Accountant issued Certificate of Availability of Funds (CAF) amounting to SIX HUNDRED TWENTY THOUSAND PESOS ONLY (Php 620,000.00). A

copy of the CAF is hereto attached as ANNEX "D" and made an integral part of this Agreement;

WHEREAS, on 22 February 2023, the Head of the Procuring Entity approved the NPC-BAC Resolution No. 011-2023, Series of 2023, recommending the Award of Contract for TELEPHONE-LANDLINE to PLDT INC.;

WHEREAS, NPC has awarded above-mentioned project to PLDT INC. and has confirmed award amounting to a total contract price of TWO HUNDRED FORTY-FOUR THOUSAND ONE HUNDRED SIXTY PESOS ONLY (Php244,160.00) inclusive of all applicable taxes, duties, fees, levies and other charges imposed under applicable laws. A copy of the Notice of Award is hereto attached as ANNEX "E" and made an integral part of this Agreement;

NOW, THEREFORE, NPC and SERVICE PROVIDER in consideration of the mutual covenants hereinafter set forth agree as follows:

1. **SCOPE OF WORK.** The terms and conditions of the Original Contract and all agreements related thereto, such as renewal contracts and extension contracts, shall be read and construed as part of this Agreement. Any and all parts of the Original Contract which are not inconsistent with this Agreement shall remain unchanged and in full force and effect.
2. **DURATION.** The SERVICE PROVIDER shall supply, install, and deliver the Telephone-Landline to the National Privacy Commission located at 5th Floor, Delegation Building, PICC Complex, Pasay City. The Contract will begin from March 1, 2023 and continue until 31 December 2023.
3. **CONTRACT PRICE.** In consideration of the SERVICES to be rendered by the SERVICE PROVIDER, the total contract price shall be TWO HUNDRED FORTY-FOUR THOUSAND ONE HUNDRED SIXTY PESOS ONLY (Php244,160.00), inclusive of all applicable taxes, duties, fees, levies, and other charges imposed under applicable laws.
4. **PRE-TERMINATION OF AGREEMENT.** The NPC may immediately terminate this Agreement upon service and delivery of a notice of termination to the SERVICE PROVIDER on any of the following grounds: (1) failure to perform or materially breach, any of its obligations, covenants, or representations as set forth in the Original Contract and all other agreements related thereto; (2) failure to produce a result that meets the specifications provided for in the Original Contract and all other agreements related thereto; and (3) when the failure or breach is serious enough to materially harm or otherwise reduce the value of the Original Contract, and all other agreements related thereto.

In the event of termination, payment of the contract price will be made to the SERVICE PROVIDER only for the services rendered up to the date of termination.

The NPC shall pay the SERVICE PROVIDER a monthly rate of TWENTY FOUR THOUSAND FOUR HUNDRED SIXTEEN PESOS (Php24,416.00) inclusive of all applicable taxes.

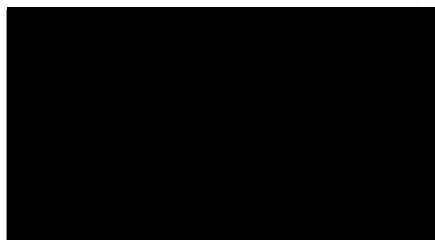

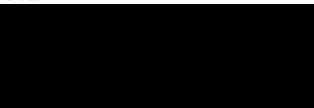
