**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF
PEST CONTROL SERVICES (APP ITEM NO. 2023-0020)**

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, Section 5(r) of Republic Act (R.A.) No. 9184, otherwise known as the Government Procurement Reform Act, provides for the procurement of goods, including general support services which includes analogous services such as health maintenance services, and other services essential to the operation of the Procuring Entity;

WHEREAS, the end-user, the Administrative Services Division (ASD) intends to procure Pest Control Services under APP Item No. 2023-0020, to determine the source and severity of the pest infestation in the NPC office and to apply the necessary treatment plan that is both safe and eco-friendly;

WHEREAS, this procurement is has a Certification of Availability of Funds (CAF) with an Approved Budget for the Contract amounting to Three Hundred Thirty Thousand Pesos (Php 330,000.00), that will determine;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184, allows for an alternative method of procurement through Small Value Procurement when the amount involved does not exceed the thresholds prescribed in Annex "H" of said IRR;

WHEREAS, a Request for Quotation (RFQ) was posted at the PhilGEPS website, at the NPC website, and social media pages. It was likewise sent to five (5) suppliers namely: Top Notch Pest Control, Mr. Pest Control, Calf Tech Pest Control, Pesticon Enterprises Inc., and Powerhouse Pest Control Services.

WHEREAS, Powerhouse Pest Control Services and Pesticon Enterprises Inc. submitted their quotation as requested;

WHEREAS, upon due evaluation, Powerhouse Pest Control Services has been determined to have the single calculated and responsive quotation with a bid price of P 100,621.60, after passing the technical, legal, and financial requirements mandated under R.A. 9184;
