## RECOMMENDING THE AWARD OF CONTRACT FOR PUBLICATION OF NPC ISSUANCES (APP ITEM NO. 2023-0042)

WHEREAS, the National Privacy Commission (NPC or Commission) is the agency mandated to administer Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, Section 7 of the DPA charged NPC with the administration and implementation of the provisions of the law, which includes ensuring compliance with the provisions of the DPA and with the international standards for data protection and carrying out efforts to formulate and implement plans and policies that strengthen the protection of personal information in the country, in coordination with other government agencies and the private sector;

WHEREAS, the NPC, through the Privacy Policy Office (PPO or end-user) sought three publications of its issuances in order to effectively carry-out its above stated mandate;

WHEREAS, the certification of availability of funds for this procurement was issued on the 16th day of March 2023 and chargeable against Printing and Publication Expenses (OPERATIONS-MOOE) under the General Appropriations Act of 2023 (RA 11936), programmed under NPC CY 2023 with Approved Budget of Contract (ABC) of Php 200,000.00;

WHEREAS, Section 53.6 of the Revised IRR of Republic Act No. 9184, provides that goods and services can be contracted to a particular supplier if the requirement is for media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media;

WHEREAS, a Request for Quotation was posted in PhilGEPS, and the NPC website and bulletin board, and was likewise sent to three suppliers namely the Concept and Information Group, Inc., The Manila Times Publishing Corp., and Philippine Daily Inquirer, Inc.;

WHEREAS, the three suppliers, Concept and Information Group, Inc., The Manila Times Publishing Corp., and Philippine Daily Inquirer, Inc. proceeded to submit their quotations;

WHEREAS, on 13 April 2023, the NPC - Bids and Awards Committee (BAC) evaluated the submissions and determined that Concept and Information Group, Inc., with a bid price of Php 146, 966.40 as the lowest calculated responsive quotation and that it passed the technical,




