**RECOMMENDING THE AWARD FOR THE PROCUREMENT OF PAW PLAQUES TO  
TOKEN AVENUE FOR BEING THE SINGLE CALCULATED AND RESPONSIVE  
QUOTATION (APP Item No. 2023-0052)**

---

**WHEREAS**, the National Privacy Commission (NPC) is an independent body mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012, and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, pursuant to Proclamation No. 527 dated 3 July 2018, the NPC will be conducting its 6<sup>th</sup> Privacy Awareness Week (PAW) on 25 May 2023;

**WHEREAS**, the NPC approved its FY 2023 Annual Procurement Plan (APP) which includes the procurement of PAW Plaques under APP Item No. 2023-0052 with the Approved Budget for the Contract amounting to Seventy-Five Thousand Pesos (Php75,000.00);

**WHEREAS**, the procurement of the PAW Plaques is for the PAW 2023 Awards activity which is part of the NPC's celebration of the 6<sup>th</sup> Privacy Awareness Week (PAW);

**WHEREAS**, said procurement is necessary to support the NPC's mandate by serving as tokens of excellence in the efforts of organizations and individuals in implementing data protection directives and as motivation to different entities to continually participate in the programs and initiatives of the NPC;

**WHEREAS**, a Request for Quotation (RFQ) was posted in PHILGEPS, the NPC website, NPC social media page, and the NPC bulletin board. The same was likewise sent to: (1) Silentworker Marketing; (2) Zioneyes General Merchandise; (3) Ban Bee Commercial Co., Inc.; (4) DVK Philippines; (5) King of Kings Trading; (6) Work Habits Trading; (7) Erica Navera. Only two (2) entities submitted their quotations: (1) King of Kings Trading; and (2) Token Avenue Trading;

**WHEREAS**, on 28 April 2023, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate all the submitted quotations and determined that **Token Avenue** has passed the technical, legal, and financial requirements mandated under RA 9184 and was determined to have submitted the lowest calculated and responsive quotation at a bid price of Seventy-Four Thousand Four Hundred Pesos (Php74,400.00);

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for the procurement of PAW Plaques to **TOKEN AVENUE**
