RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PUBLICATION OF NPC CIRCULAR 2023-05 (APP Item No. 2023-0076)

WHEREAS, the National Privacy Commission (NPC) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC-Data Security and Technology Standards Division (DSTSD) is responsible for developing and issuing guidelines on physical and technical security measures for data protection using the most appropriate standards recognized by the information and communications technology industry;

WHEREAS, the NPC is developing the Philippine Privacy Mark (PPM), Certification Program, a voluntary certification program, to assess public and private organizations that implement data privacy and protection management systems to ensure the secure and protected processing of personal information;

WHEREAS, Section 53.6 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Alternative Mode (Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services) as a method of procuring goods and services, and can be contracted to a particular supplier if the requirement is for media, documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communications media;

WHEREAS, this procurement has a Certification of Availability of Funds (CAF) with APP Item No. 2023-0076 with an Approved Budget for Contract of Php120,000.00;

WHEREAS, a Request for Quotation was posted in PhilGEPs, and NPC website and bulletin board, and was likewise sent to three (3) suppliers, namely; Philippine Daily Inquirer, Inc., Concept and Information Group, Inc., The Manila Times Publishing Corp., Malaya Business Insight, Philstar, Daily Tribune, Business Mirror, Business World;

WHEREAS, three (3) bidders submitted their quotations namely: (1) Peoples Independent Media, Inc.; (2) The Philippine Daily Inquirer, Inc.; (3) Concept and Information Group, Inc. (Daily Tribune);

WHEREAS, on 20 February 2024, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations and determined that Concept and Information Group, Inc. has the lowest calculated and responsive quotation with a bid price amounting to Twenty-Seven Thousand Two Hundred Sixteen Pesos (Php27,216.00)
