#### RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PUBLICATION OF REPEAL OF NPC CIRCULAR 16-01 (APP Item No. 2023-0077)

WHEREAS, the National Privacy Commission (NPC) is an independent regulatory body responsible for the enforcement and implementation of Republic Act No. 10173, known as the Data Privacy Act of 2012. It is also tasked with monitoring and ensuring the Philippines' compliance with international data protection standards;

WHEREAS, the NPC-Data Security and Technology Standards Division (DSTSD) is responsible for developing and issuing guidelines on physical and technical security measures for data protection using the most appropriate standards recognized by the information and communications technology industry;

WHEREAS, the NPC Circular 16-01, published in 2016, provides guidelines for securing personal data within government entities. Its purpose is to aid government agencies that handle personal data in ensuring its security;

WHEREAS, the Repeal of NPC Circular 16-01 was created with the everchanging advancement of technologies that handle personal data and with the necessity to assist the private sector engaged in the processing of personal data;

WHEREAS, Section 53.6 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Alternative Mode (Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services) as a method of procuring goods and services, and can be contracted to a particular supplier if the requirement is for media, documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communications media;

**WHEREAS**, this procurement has a Certification of Availability of Funds (CAF) with APP Item No. 2023-0077 with an Approved Budget for Contract of Php120,000.00;

WHEREAS, a Request for Quotation was posted in the PhilGEPs and NPC website, as well as the NPC bulletin board on 14 February 2024;

WHEREAS, a Request for Quotation was posted in PhilGEPs, and NPC website and bulletin board, and was likewise sent to three suppliers namely Philippine Daily Inquirer, Inc., Concept and Information Group, Inc., The Manila Times Publishing Corp., Malaya Business Insight, Philstar, Daily Tribune, & Business Mirror, Business World;

WHEREAS, on February 20, 2024, the National Privacy Commission - Bids and Awards Committee (NPC-BAC) evaluated the submitted quotations and found that Concept and
