# RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PSST WEBCAST TOKENS (APP Item No.2024-0037)

WHEREAS, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the National Privacy Commission (NPC) shall undertake appropriate and necessary efforts to inform and educate the public about data privacy, data protection, and fair information rights and responsibilities, as mandated by the Data Privacy Act of 2012 and its implementing rules and regulations;

WHEREAS, the NPC, as the agency mandated to administer and implement data privacy and to be a world-class regulatory agency, is implementing the Public, Safety, Security and Trust Online (PSST), which is an advocacy campaign that emphasizes the central role of data subjects in creating a digital democratic space conducive to privacy, safety, security, and trust;

WHEREAS, the NPC, through its Public Information and Assistance Division (PIAD), as the end-user, is responsible for information management, including raising awareness and providing valuable insights into the field of digital privacy and security;

WHEREAS, the NPC approved its FY 2024 Annual Procurement Plan (APP), which includes the procurement of PRIVACY SAFETY, SECURITY, and TRUST (PSST) Webcast Tokens under APP Item No. 2024-0037 with the Approved Budget for the Contract (ABC) of Two Hundred Thousand Pesos (Php200,000.00).

**WHEREAS**, Section 53.10 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes Small Value Procurement (SVP) as an alternative mode of procurement to promote economy and efficiency;

**WHEREAS**, on 03 August 2024, the NPC Bids and Awards Committee (NPC-BAC), through its Secretariat, sent Requests for Quotation (RFQ), through electronic mail, to three (3) suppliers. The RFQ was also posted on the PhilGEPS and NPC websites as well as the NPC bulletin board;

WHEREAS, on 16 August 2024, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotation from four (4) prospective bidders based on requirements mandated under RA 9184 and its IRR;

WHEREAS, as stated in the Technical Specification, the qualified bidder shall submit a sample of the fabric to be used prior to the issuance of the Notice of Award to determine that the qualified bidder complies with technical specifications. Thus, the end-user was directed by the BAC to proceed with the post-qualification as regards to sample fabric being submitted by the qualified bidders;

WHEREAS, the BAC Members determined that three (3) suppliers are compliant to undergo the post-qualification, namely; Zioneyes General Merchandise, JDR Trading Services, and Elev8 Trading and Marketing Corporation;

WHEREAS, PIAD, as the end-user, submitted a Memorandum of Evaluation Report on Checklist for the PSST Webcast Tokens containing its recommendation. Based on their recommendation, Zioneyes General Merchandise and JDR Trading Services submitted sample item and Elev8 Trading and Marketing Corporation failed to submit the said sample item. Furthermore, based on the recommendation Zioneyes General Merchandise is compliant with the technical specification based on the Inspection Checklist and Assessment;

**WHEREAS**, the NPC-BAC then determined that Zioneyes General Merchandise submitted the single calculated and responsive quotation amounting to One Hundred eighty Thousand Nine Hundred Fifty Pesos (Php180,950.00) and is compliant with technical specifications;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the procurement of PSST WEBCAST TOKENS to ZIONEYES GENERAL MERCHANDISE for being the single calculated and responsive quotation with the total amount of One Hundred eighty Thousand Nine Hundred Fifty Pesos (PHP180,950.00), subject to the presentation of their original documentary requirements upon the signing of the Notice of Award (NOA).
