BAC Resolution No. 024-2024, Series of 2024

**RECOMMENDING THE AWARD OF CONTRACT FOR NATIONAL WOMEN'S  
MONTH CELEBRATION (NWMC) ADVOCACY TOKEN  
(APP Item No. 2024-0039)**

---

**WHEREAS**, the National Privacy Commission (NPC) is an independent body mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act (DPA) of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, the Philippines commemorates National Women's Month every March to honor women's tireless efforts and dedication for the betterment of society, as well as to continuously promote gender equality and women's rights all over the country;

**WHEREAS**, the celebration is rooted in International Women's Day (IWD), which takes place every 8<sup>th</sup> day of March across the world. The month-long celebration in the Philippines was instituted by then-President Corazon Aquino's Proclamation No. 227 in 1988. This proclamation designated the first week of March as Women's Week and the 8<sup>th</sup> day of March as Women's Rights and International Peace Day. Proclamation No. 227 was later converted into Republic Act No. 6949 which formally recognizes March as the National Women's Month of the Philippines;

**WHEREAS**, during the National Women's Month Celebration (NWMC), several government departments and agencies, non-government organizations (NGOs), women's rights groups, and civil society organizations arrange programs and activities aimed at increasing awareness about issues affecting women, promoting gender equality, and recognizing the achievements of women in disciplines such as political discourse, academics, sciences, arts, athletics, and enterprises;

**WHEREAS**, the NPC supports the Philippines' advocacy for a Bagong Pilipinas for women, which would provide them with equal opportunities free of gender stereotypes by commemorating National Women's Month. The NPC, through its GAD Committee together with various offices, divisions, committees, and units, is all for Gender Equality and an Inclusive Society;

**WHEREAS**, this procurement has a Certification of Availability of Funds (CAF) with an Approved Budget for the Contract of Two Hundred Thousand Pesos (Php200,000.00) and has been confirmed to be existing as APP Item 2024-0039 in the NPC FY 2024 chargeable against Training Expenses (*Operations-MOOE*), under the General Appropriations Act of 2024 (RA 11975);

**WHEREAS**, based on the market study previously conducted by the end-user to determine the probable sources, the providers who were determined to have the capacity to undertake the project at a more advantageous terms and are technically, legally, and financially capable

are Berachah Advertising Services, King of Kings. Trading, Macjab Industrial Chemical Products Wholesaling, VJ Graphic Arts, Inc., and Elev8 Trading and Marketing Corporation;

**WHEREAS**, a Request for Quotation (RFQ) was posted in PhilGEPS, the NPC website, and the NPC bulletin board and was likewise sent to five (5) suppliers, namely: Berachah Advertising Services, King of Kings. Trading, Macjab Industrial Chemical Products Wholesaling, VJ Graphic Arts, Inc., and Elev8 Trading and Marketing Corporation;

**WHEREAS**, the Berachah Advertising Services, King of Kings Trading, Macjab Industrial Chemical Products Wholesaling, VJ Graphic Arts, Inc., and Elev8 Trading and Marketing Corporation proceeded to submit their quotations as requested;

**WHEREAS**, on 16 April 2024, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) evaluated the submissions and determined that Elev8 Trading and Marketing Corporation with a bid price of P174,000.00 as the lowest calculated and responsive quotation and that it passed all the technical, legal, and financial requirements under RA 9184 and its 2016 Revised Implementing Rules and Regulations;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of **CONTRACT FOR NATIONAL WOMEN'S MONTH CELEBRATION (NWMC) ADVOCACY TOKEN** to **ELEV8 TRADING AND MARKETING CORPORATION** in the total amount One Hundred Seventy-Four Thousand Pesos (P174,000.00), subject to the presentation of their original documentary requirements upon the signing of the Notice of Award (NOA).

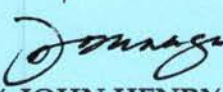
