Resolution No. 077-2024, Series of 2024

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF 18-DAY CAMPAIGN TO END VIOLENCE AGAINST WOMEN AND CHILDREN - ADVOCACY TOKENS
(APP Item No.2024-0040)

WHEREAS, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, Violence Against Women (VAW) is a pervasive social problem not just in the Philippines but worldwide, affecting an estimated 1 in 3 women. The 2022 National Demographic and Health Survey (NDHS) released by the Philippine Statistics Authority (PSA) reveals that nearly 1 and out of 5 women have experienced emotional, physical, or sexual violence by their current or most recent husband or intimate partner. In 2023 alone 8,055 cases classified under the Republic Act No. 9262 Anti-Violence Against Women and Children Act (2024) were reported to the Philippine National Police (PNP);

WHEREAS, with the goal to be a VAW-free country, the Philippine Commission on Women (PCW) issued Memorandum Circular No. 2024-04 Guide for 2024 Observance of the 18-day Campaign to End Violence Against Women (VAW) dated 16 September 2024. This issuance requires all National Government Agencies and Instrumentalities on the observance of the 18-day Campaign to End Violence Against Women (VAW) commencing on 25 November to 12 December 2024;

WHEREAS, the 2022-2027 recurring campaign theme, "UNITED for VAW-free Philippines" and its 2024 sub-theme, "VAW Bigyang Wakas, Ngayon na ang Oras", wherein every Filipino, much as the NPC as a government agency, has the power to help end VAW, and OUR TIME TO ACT IS NOW. Additionally, the PCW highlights the urgency of the advocacy in line with the commemoration of the 20th anniversary of the signing of the Anti-VAWC Act of 2024 (RA 9262);

WHEREAS, this year, the National Privacy Commission through the Gender and Development (GAD) Focal Point System-Technical Working Group (FPS-TWG) Committee shall lead, coordinate, and facilitate the yearly Observance of 18-Day Campaign to End VAW from 25 November to 12 December with series of activities;

WHEREAS, the NPC approved its FY 2024 Annual Procurement Plan (APP), which includes the procurement of 18-DAY CAMPAIGN TO END VIOLENCE AGAINST WOMEN AND CHILDREN - ADVOCACY TOKENS under APP Item No. 2024-0040 with the Approved Budget for the Contract (ABC) of Two Hundred Thousand Pesos (PHP 200,000.00).

WHEREAS, Section 53.10 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes the use of Small value Procurement as an alternative mode of procurement to promote economy and efficiency;

WHEREAS, on 29 October 2024, the NPC Bids and Awards Committee (NPC-BAC), through its Secretariat, sent Requests for Quotation (RFQ) through electronic mail and the same was also posted on the PhilGEPS, NPC website as well as the NPC bulletin board;

WHEREAS, on 04 November 2024, the NPC BAC proceeded to evaluate the submitted quotation based on requirements mandated under RA 9184 and its IRR;

WHEREAS, as stated in the Technical Specification, the end-user required a Post-Qualification requirement stating that the qualified bidder shall submit a sample copy prior to the issuance of the Notice of Award to determine the qualified bidder complies and is responsive to the technical specifications;


WHEREAS, the NPC-BAC determined that one prospective supplier is compliant with the requirements subjected to post-qualification: Zioneyes General Merchandise. It was moved and seconded that the supplier undergo post-evaluation/qualification as stated in the Technical Specification;


WHEREAS, on 08 November 2024, the NPC -BAC proceeded for post evaluation/qualification and was determined Zioneyes General Merchandise that it passed the technical, legal and financial requirements mandated under RA 9184;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for the procurement of **18-DAY CAMPAIGN TO END VIOLENCE AGAINST WOMEN AND CHILDREN - ADVOCACY TOKENS** to **ZIONEYES GENERAL MERCHANDISE** for being the single calculated and responsive quotation with the total amount of One Hundred Seventy-Seven Thousand Six Hundred Pesos (**PHP177,600.00**), subject to the presentation of their original documentary requirements upon the signing of the Notice of Award (NOA).
