RECOMMENDING THE AWARD OF CONTRACT FOR THE GENDER AND DEVELOPMENT (REPRESENTATION EXPENSES)

WHEREAS, the National Privacy Commission (NPC) is an independent body mandated to administer and implement the Data Privacy Act of 2012 (DPA), and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC is mandated by Republic Act No. 9710, the Magna Carta of Women (MCW), to integrate gender mainstreaming into its policies and practices. Gender mainstreaming is crucial for promoting women's human rights and eliminating gender discrimination, as outlined in the MCW;

WHEREAS, the MCW requires government agencies to allocate at least 5% of their total budget for programs addressing gender issues. This includes developing annual Gender and Development (GAD) Plans and Budget and complying with PCW Memorandum No. 20184)4 and 2018-05, which specify reporting and planning requirements. Furthermore, Executive Order 273 series of 1995 directs appropriate steps to ensure full implementation of the policies, strategies, programs, and project outlines in the Philippine Plan for Gender-Responsive Development;

WHEREAS, the NPC GAD Focal Point System -Technical Working Group (FPS-TWG) ensures the effective and efficient implementation of the agency's GAD programs, activities and projects, and compliance with all reportorial requirements of oversight agencies. Therefore, the NPC GAD FPS-TWG acknowledges the need to sustain the implementation and support for the development and continuous implementation of NPC GAD plans and budget;

WHEREAS, Section 50 of Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act" allows Direct Contracting as an alternative mode of procurement and the Revised Implementing Rules and Regulations (RIRR) of RA 9184 provides for the guidelines for Alternative Modes of Procurement including Direct Contracting;

WHEREAS, Section 14 of the Contract to Lease between the NPC and the Philippine International Convention Center (PICC) provides that: "The LESSEE shall not be allowed to bring in, for large or extraordinary events or celebration, catered food and beverages inside the Leased Premises, since LESSOR has an exclusive food concessionaire. Accordingly, it shall make arrangements with such concessionaire for the food and beverage requirements for its meetings and other events inside the Leased Premises as well as for the personal requirements of its officers and employees";
