**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF
JOINT CYBER SECURITY WORKING GROUP - TOKENS (APP Item No.2024-0050)**

WHEREAS; the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS; the Joint Cyber Security Working Group (JCSWG) was created by the partnership of the Office of the Legal Attachè (LEGAT) in Manila, the United States (U.S.) Department of State, the Philippine Government, and private sector companies to promote intelligence sharing and policy development through training and technical assistance to law enforcement personnel to be able to enhance Philippine law enforcement operations related to cybersecurity;

WHEREAS; the NPC, through its Enforcement Division (EnD), has been hosting the JCSWG, wherein it invites national agencies, local and international, as well as the private sector to participate in tackling trends that concern data privacy within the Philippines and abroad;

WHEREAS; the NPC approved its FY 2024 Annual Procurement Plan (APP), which includes the procurement of Joint Cybersecurity Working Group – Tokens under APP Item No. 2024-0050 with the Approved Budget for the Contract (ABC) of Fifty Thousand Pesos (PhP50,000.00);

WHEREAS, Section 53.10 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes the use of Tokens as an alternative mode of procurement to promote economy and efficiency;

WHEREAS, on 30 July 2024 , the NPC Bids and Awards Committee (NPC-BAC), through its Secretariat, sent Requests for Quotation (RFQ) through electronic mail to Zioneyes General Merchandise. The Request for Quotation was also posted on the PhilGEPS and NPC websites as well as the NPC bulletin board;

WHEREAS, on 12 August 2024, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotation from **ZIONEYES GENERAL MERCHANDISE** and identified that it passed the technical, legal and financial requirements mandated under RA 9184 and its IRR;

WHEREAS, the NPC-BAC likewise determined that **ZIONEYES GENERAL MERCHANDISE** submitted the single calculated and responsive quotation amounting to Forty-Eight Thousand Eight Hundred Seventy Pesos (PhP48,870.00).

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for the procurement of **JOINT CYBERSECURITY WORKING GROUP - TOKENS** to **ZIONEYES GENERAL MERCHANDISE** for being the single calculated and responsive quotation with the total amount of Forty Eight Thousand Eight Hundred Seventy Pesos (**PHP48,870.00**), subject to the presentation of their original documentary requirements upon the signing of the Notice of Award (NOA).
