**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF  
FY2025 OPERATIONAL PLANNING AND CONDUCT OF FY2025 GAD PLANS AND  
BUDGET WORKSHOP – TRANSPORTATION**

---

**WHEREAS**, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, through the years, the NPC similar with other government agencies and instrumentalities, regularly conducts its Operational Planning;

**WHEREAS**, the annual planning exercise outlines the specific actions and resources needed by the Commission in its day-to-day operations to implement broader strategic plans;

**WHEREAS**, the activity involves setting detailed goals, identifying tasks, assigning responsibilities and allocating resources;

**WHEREAS**, as the Commission enters the stage of strategic growth and as it examines its 2025 Operational Plans to better match the overall targets set out in its 2023-2028 Strategic Plans aligned with the PDP framework, the NPC seeks to improve its operational strategies and optimize its efficiency of strategic initiatives and to assist the Commission in addressing hurdles and capturing the opportunities;

**WHEREAS**, the NPC approved its FY 2024 Annual Procurement Plan (APP), which includes the procurement of the above-mentioned item under APP Item No. 2024-0061 with the Approved Budget amounting to One Hundred Eighty Thousand Pesos (Php180,000.00);

**WHEREAS**, Section 53.10 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes Small Value Procurement (SVP) as alternative mode of procurement to promote economy and efficiency;

**WHEREAS**, on 01 October 2024, the NPC Bids and Awards Committee (NPC-BAC) sent Request for Quotation (RFQ), through electronic email. The RFQ was also posted on the PhilGEPS and NPC websites as well as the NPC bulletin board;

**WHEREAS**, one (1) bidders submitted its quotations, namely: (1) Kinglang Tours and Transport Services Inc.;

**WHEREAS**, on 30<sup>th</sup> October 2024, the NPC Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations and determined that Kinglang Tours and Transport Services Inc. has the single calculated and responsive quotation with a bid price amounting to One Hundred Eighty Thousand Pesos (Php180,000.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the procurement of **FY2025 OPERATIONAL PLANNING AND CONDUCT OF FY2025 GAD PLANS AND BUDGET WORKSHOP - TRANSPORTATION to KINGLANG TOURS AND TRANSPORT SERVICES INC.** for being the single calculated and responsive quotation with the total amount of **One Hundred Eighty Thousand Pesos (Php180,000.00)** subject to the presentation of their original documentary requirements upon the signing of the Notice of Award (NOA).



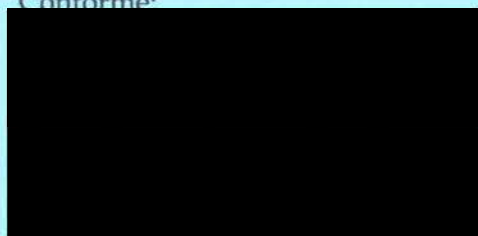
